ASH 7/18 Evacuation Procedure

ASH 9/18 Minutes of Meetings Held on 13th February and 13th March 2018

The minutes of the meetings held on 13 February and 13 March 2018 were confirmed and signed as a correct record.

ASH 10/18 Scrutiny Review of Gambling

Members received a presentation relating to a preventative and educational Youth Gambling Initiative provided by the Edinburgh based Charity 'Fast Forward'

It was explained that the initiative took a harm reduction approach, and a Toolkit had been produced to develop the skills and confidence of practitioners, when supporting young people. Pilot schemes had been provided in schools.

Prior to the pilot there was limited awareness of the issues around gambling amongst practitioners, and it was often thought that it was not an issue in the young people they worked with. However, it was noted that during sessions, once the issue had been raised with young people, they began to mention how it had affected them.

Members asked a number of questions relating to the funding of the initiative and the prevalence and risk factors associated with Children and Young People gambling in that area of Scotland.

The Committee continued discussion on the gambling behaviors of Children and Young People living in the Borough.

- Representatives from the Stockton Riverside College and Stockton sixth form college indicated that gambling was a not a significant focus, in terms of the

need to provide support to students. However, there were a small number of students who had been identified as needing some support. Issues around drugs and alcohol were much more evident on a day to day basis.

- a college representative made reference to an issue that had arisen in a secondary school setting, that he had previously worked in. Year eleven, male pupils had become involved in sports spot betting and the school had intervened via its pastoral programme.

- Public Health had undertaken a mapping exercise amongst services who worked with young people in the Borough. The Council had also undertaken a survey amongst school children on an annual basis and questions around gambling had been added this year.

- practitioners, working with children, did not highlight gambling as an issue that children and young people were routinely discussing as a problem.

- services had limited awareness of what support they could access, if a young person presented, with a gambling concern.

- problematic gambling, amongst young people, was extremely low but the risks associated with it were high.

- it was important to work with young people to get them to think about the consequences of gambling, at a targeted and universal level.

- Members noted that advertising was extensive and may have an affect on young people's decisions around gambling. It was important to have prevention education in schools and signpost young people to support.

- the health behaviour survey of school children was likely to provide useful data on gambling prevalence and problems etc.

- members were concerned about skin betting, which appeared to introduce gambling behaviors to children and young people as part of computer gaming.

RESOLVED that the information provided and discussion be noted.

ASH Quarterly CQC Inspections Update
