What we told the CQC we were concerned about before the inspection



- Incident reporting and learning across the organisation
- Staff engagement
- Diagnostic services (response times, workforce challenges)
- Patient access – RTT and Cancer
- Our long standing and underlying financial challenges
- Our need for an EPR to improve patient safety
- Pace of change required to achieve financial regulatory requirements in year

What was good?

- Patients told the CQC that they received compassionate care
- Staff worked well within teams and supported each other to provide good care
- Medical and Surgical services appropriately staffed
- Care plans and risk assessments generally completed in detail
- Both hospital sites were clean
- Staff applied safeguarding procedures
- All outlying medical patients had evidence of a daily senior medical review
- All DOLs were appropriately completed
- The therapeutic care volunteers were great

Improvement Plans

- Detailed action plan submitted to the CQC on the 24 July 2019
- Internal governance process agreed to track improvement and to provide Board assurance
- Regulator and Commissioner oversight, scrutiny and assurance

Action plan themes

- Review of Board to Ward Governance processes (report end September 19)
- Improve staff engagement and involvement
- Critical Care, managing demand, capacity and associated staffing levels
- Environment in the Emergency Department (children and patients with mental health needs)
- Improve Mandatory Training rates
- Improve Appraisal Rates
- Ensure provision of medicines reconciliation is at the required level

Action plan themes

- Improve Incident reporting, actions and learning
- Ensure risk registers accurately reflect practice
- Ensure 100% compliance with Duty of Candour
- Ensure all Major Trauma Standards are met
- Ensure strict adherence to infection prevention and control and pressure ulcer prevention strategies in critical care
