

## **Adult Social Care and Health Select Committee**

A meeting of Adult Social Care and Health Select Committee was held on Tuesday, 10th December, 2019.

### **ASH 40/19 Evacuation Procedure**

The Chair welcomed everyone to the meeting and the evacuation procedure was noted.

### **ASH 41/19 Declarations of Interest**

No interests were declared.

### **ASH 42/19 Minutes from the meeting on 12th November 2019 for approval / signature**

Consideration was given to the minutes from the meeting held on 12th November 2019.

AGREED that the minutes from the meeting held on 12th November 2019 be confirmed and signed as a correct record.

### **ASH 43/19 Teeswide Safeguarding Adults Board (TSAB) - Annual Report 2018-2019**

Consideration was given to the Teeswide Safeguarding Adults Board (TSAB) Annual Report 2018-2019 and Strategic Business Plan 2019-2020 which was presented by the TSAB Independent Chair.

The main issues discussed during the presentation and in response to the Committee's questions were as follows:

- Good practice and resources were shared across the four Local Authority areas that are covered by the TSAB, as well as the other statutory partners (Cleveland Police and local CCGs. However, the TSAB acknowledge that there could be challenges around links to the ground in each of the four localities. It is important that the Board is not just a talking shop.
- Safeguarding concerns and Section 42 enquiries in adults had risen over the last year; this could be due to more safeguarding awareness. More abuse took place in homes and not Care Homes.
- Discussion took place around the difficulty in safeguarding adults due to an individual's capacity; there was a balance between personal choice and statutory responsibility.

- Stockton has the highest number of Safe Places in the Borough and Cleveland Fire Service provide Stay Safe and Warm visits to residents – two very positive initiatives in terms of safeguarding.
- It is the statutory duty of the Adult Safeguarding Board to look at the quality of training through multi-agency audits.
- Safeguarding adults is something that is everyone's business, but this can lead to it being nobody's business (e.g. Domestic Abuse) – a key ongoing challenge is how the Board and its partners can work better together and best use their collective resources.
- Members were informed that some people misuse alcohol or drugs to gain access to hospital so they have a bed for the night.
- Most serious adult reviews (SARs) following a death concern middle-aged people who have led a chaotic lifestyle. They are often known to services but are very hard to help.
- Members suggested that including trend data in future TSAB Annual Reports would be useful (e.g. Where did Adult Abuse Occur (page 5)). An explanation around what constituted a 'concern' and a 'Section 42 Enquiry' was also proposed (page 5).
- Discussion took place around the situations that cause domestic abuse, with cases within BME communities highlighted. It was noted that some cases involve different types of abuse.
- Regarding the Deprivation of Liberty Safeguards (DoLS), Members asked if the Board receive feedback on this from Local Authorities, and expressed concern that this had become a process where the individual is lost. The Independent Chair acknowledged the danger that it becomes a paper exercise, and is often a poor experience for families / carers. TSAB have provided its own feedback nationally and have seen draft changes in the Government Green Paper. Members encouraged the gathering of views from all stakeholders involved in DoLS.
- Concerns around Social Care for adults and children being at odds with each other was expressed by Members, as was safeguarding within care homes. Regarding the latter, there were a high number of medication errors taking place in care homes previously, but Board-led work on this has led to a 20% reduction in errors. The high staff turnover ('churn') within care homes can affect quality, and challenges remain around changing the perceptions of people who do not see care jobs as skilled roles.
- In terms of training, more feedback on this could be provided in future TSAB reports. It was reported that high workloads can prevent staff accessing training, and that some staff question the benefits of online courses as they cannot discuss issues or interact with other professionals.
