I write in reply to your objection to the above proposal as recently advertised which has been formally received by the Legal Services Department.

I would like to take this opportunity to give you some background information on the proposal. Surbiton Road was selected for feasibility study in the financial year 2008/09 following seven reported injury accidents in the previous five year period and also in response to residents concerns relating to speeds of vehicles.

Residents with properties accessed directly off Surbiton Road or a property accessed via Surbiton Road only were consulted on proposals to reduce traffic speeds in March 2008. Comments were incorporated where practicable and directly affected residents were reconsulted in July 2008. An agreed scheme was presented to the Head of Service and appropriate Cabinet Member in September 2008 when the scheme became a contender for funding.

Road humps are one of the most effective traffic calming measures available to local authorities. Each 1mph reduction in vehicle speed resulting from traffic calming has been found to reduce accidents by around 5%. A scheme to introduce speed cushions along the full length of Surbiton Road was investigated at residents requests which would have resulted in 12 sets of cushions. However, this was not supported by the Police or local bus operators and was subsequently withdrawn. The advertised proposals are for speed cushions at three locations along the length of Surbiton Road which is approximately 1430 metres long and also for a raised table top feature at the Culross Grove junction.

The Government's traffic calming policies are evidence based and thereby undergo extensive tests a trials before they are introduced nationally. Regulations relating to the dimensions of road humps can be found in 'The Highways (Road Humps) Regulations 1999. This Legislation prescribes road humps must be between 25mm and 100mm in height. A height of up to 100mm is permissible although The Department for Transport recommends the use of 75mm high. The proposed speed cushions on Surbiton Road will not exceed 75mm in height.

Provided the features conform to the dimensions specified in the guidance, vehicles travelling over them at appropriately low speeds should not suffer damage and the Council, as Highway Authority would not be liable to any damage caused to vehicles.

In response to your second point I can advise that the Officers Traffic Group were consulted on all of the proposals including the agreed scheme. The Officers Traffic Group is a regular meeting attended by Senior Traffic Engineers, Enforcement Officers, local bus operators and representatives from the Emergency Services and Cleveland Police. The Group had no objections to the final scheme. In addition, as part of the statutory procedure the emergency services also receive a copy of the Notice from Legal Services and so have a further opportunity to object.

Given the length of the road and wide grass verges on Surbiton Road it is considered that physical measures are required in order to reduce vehicle speeds.

It is not proposed to restrict access to Surbiton Road.

As you have responded to the statutory advertisement within the objection period, the next stage is to ask you to consider your objection. If you wish your objection to stand the item will be referred to the Appeals and Complaints Committee for consideration.

The Committee is independent and as an objector you would be given every opportunity to address the Committee. The alternative is for you to formally withdraw your objection.

A reply slip and pre-paid envelope are enclosed for you to indicate your intentions.

I would be grateful if you could return your completed reply slip within 10 working days of the date of this letter.
