1.1	Achieve the national Department for Children Schools and Families (DCSF) target of all eligible schools to have an authorised school travel plan in place by 2010	Neil Ellison

1.3	Implementation, through the travel plan process, and as appropriate opportunities arise, 'Safer Routes to school' supporting the School Travel Plans delivery

1.5	Roll out a programme of education, training and publicity in support of infrastructure improvements for vulnerable users, thus increasing the attractiveness of more sustainable alternatives to the private car
