<p>Matters Arising Communities Fund Update The BOOST partnership has now been renamed as 'Work Steps'.</p>			
<p>Financial Inclusion in the Borough Diane Patterson, Chair of the borough's Financial Inclusion Forum provided an overview of financial inclusion in the borough.</p> <p>It was confirmed that press releases will be taking place for the 'Busting the Credit Crunch' drop in session to be held at Billingham and a stall in the market and street entertainment in order to attract attention. A pre meeting will be held to discuss publicising measures. Past event in Stockton was a success however Thornaby was not potentially due to venue.</p> <p>Ross Hunt gave an overview of his role as a DWP Financial Inclusion Champion.</p> <p>An overview of the work of Christians Against Poverty was given by Roy Parker. It was noted that Christians Against Poverty receive no government funding and rely upon voluntary contributions often received from past clients who have gained assistance once their financial circumstances have improved. <p>need to be a member of the Tees Credit Union to apply for a loan. There is one telephone number with access to all services offered by the Credit Union.</p> <p>The costing to produce a signposting leaflet for financial advice can be costly so a referral guide is to be produced for Front line staff. As all staff are stretched as the situation increases a self help pack is looking to be developed in order to ease pressure on services.</p> <p>SDAIS have housing related enquiry statistics by ward that can be circulated to partnership members if requested. It shows an increase in most areas of the borough including the more affluent areas.</p>			
<p>Fuel Poverty and Energy Advice</p> <p>Mike Chicken, Environmental Policy Manager, provided an update on energy saving advice and assistance for residents in particular the Community Energy Saving Programme, worth £350m which is set to focus on the most deprived areas in the country, including some areas in the borough.</p> <p>Fuel prices have experienced a 250% increase from 2003, rises in income and benefits have not increased accordingly. Warm front provided a maximum grant and the council often met the shortfall for the amount needed to complete works. Clients needed to make a contribution but many could not afford it so the PCT was approached to assist under a health initiative.</p> <p>A scheme called 'Go warm' was introduced 2 years ago which provides services such as loft insulation to identified priority areas. To promote the initiative and seek those people who require assistance 'door to door' approaches have been adopted and as a result 50,000+ people have been identified to assist in this way.</p> <p>The 'Community Energy Saving Programme' and how it is funded was briefly explained. <p>small element goes into a pot of money which is used to assist those in need. This is used in target areas from the 10% most deprived that have been identified. Approx £3.5 million could be available that could cover 90+ households in the borough.</p> <p>The government is promoting energy consumption monitoring in the home by distributing monitors that fit onto electric metres which show the cost of the energy used.</p> <p>Concern was raised that government grants are still given to tenants rather than properties and that this can cause problems in the private rented sector. It was noted that the approach is more relaxed now and this should become less of a problem.</p> <p>There might be an opportunity for the Council to make use of the information on energy performance certificates that landlords need to have for their properties.</p>			
<p>Time2Buy – The Homebuy agent for the Tees Valley and County Durham</p> <p>Rachael Swales, gave a presentation on Time2Buy, the Homebuy Agent for County Durham and Tees Valley.
