Neighbourhood Watch

Neighbourhood Watch (NW) had secured over 500 new members over the last six months and had participated in 6 events throughout the district to raise awareness.

The Junior Neighbourhood Watch (JNW) had added 6 further schools to their scheme and were now running in a total of 8 schools. The schools had had visits from the Traffic Unit and had visited the horse unit. One of the schools had a visit from the police helicopter and were given a presentation on the work that they do.

A full time project leader who was currently a volunteer was in attendance to provide Members with a presentation. It was hoped that funding through extended schools may be sought to make the post a paid position.

NW provided a service of supplying equipment to homes where people felt vulnerable. It was stated that the Safe at Home project also supplied similar items of equipment as well as the fire brigade providing fire alarms/blankets etc. to the elderly.

NW had introduced no cold calling to two areas in the borough.

NW were currently working on a business plan and were hoping to attract more funding.

It was suggested that NW provide a presentation to School Governors to raise awareness of JNW as part of the extended schools project.

NW try to work alongside neighbourhood policing, there were improved relationships between the police and residents including youths who were providing more intelligence to the police. NW try to get as much information as possible out to the public but were always looking at ways to streamline.

Port Clarence would be having their first Neighbourhood Watch meeting on 3rd March 2010.

AGREED that the information received be noted.

Recorded Crime & Disorder

Members were provided with the recorded crime figures, anti social behaviour disorder codes and Most Serious Violence figures for April – December 2009 compared with April – December 2008.

Members discussed 5.2 and 5.3 with regard to support packages for prisoners being released. Officers stated that this matter needed to be investigated further and would like to see what information was being provided to newly released prisoners who were parents of under 8s. There was a need to ensure that prison staff were aware of what support was out there. There was a need to be more proactive with Holme House and SDAIS.

It was stated that for Stockton's overall population we had the third highest population of drug users. There was a high number of problematic people in treatment. However, the DAAT was the third highest performing, it was felt that these figures didn't correlate and the DAAT would be taking this matter up with GONE.

It was stated that a support worker had been placed in the Birchtree practice. It was felt that patients who had been through treatment would be better placed in a shared care practice where they would not have to mix with problematic drug users still in the chaotic phase.

143/09** **YOS Inspection**

In 2009, HMI Probation (HMIP) introduced a new 3 year independent inspection programme of Youth Offending Services (YOS). In response to national developments relating to public protection, youth crime and the safeguarding agenda, the new inspection regime focused exclusively upon the delivery of case work and how this contributed to: managing risk of harm presented to others from children and young people; reducing the likelihood of offending; and the safeguarding of children and young people.

Stockton on Tees YOS received very positive feedback from inspectors during and following inspection. The inspection report was published 6th January 2010, with minimum recommendations for improvement in relation to all three areas of managing risk of harm; reducing likelihood of offending; and safeguarding. The full inspection report was provided for Members information.

Stockton's results compared very favourably in the North East region and places the YOS as the best performing YOS overall in the region. An improvement action plan has been prepared in response to the inspection's key recommendations to further strengthen service performance.

147/09** **Stockton Intensive Tenancy Support Service**

Stonham (Stockton Intensive Tenancy Support) had been providing support to vulnerable adults who had substance misuse issues within the borough of Stockton for 8 years and had helped to reduce anti social behaviour as well as helping clients to sustain and maintain a tenancy.

As part of the scheme, working in partnership with Probation, CJIT, Housing Options and Tristar to enable clients with a persistent prolific offending history to successfully maintain independent accommodation.

Discussion was held on the Youth Crime Action Plan and how Government funding had been

spent to reduce crime. Part of the funding had been spent targeting hot spot areas and youth work on the streets. An update would be provided at the next meeting. It was also requested that discussion be held on deployment of partnership funds at the next meeting.

AGREED that the report be noted and that an update be provided at the next meeting on the Youth Crime Action Plan and the deployment of partnership funds.
