<ul> <li>Members were also informed of the following:</li> <li>Housing – 50 new homes are to be developed on the North Shore Home Zone. Currently out to consultation for the extension of the boundary to the Parkfield housing development and have received an additional £8million from the Homes and Communities Agency for this scheme</li> <li>Globe Theatre – it is envisaged that this turn into a tour and music venue and have funding from Single Programme and Jomast working in partnership to make this into a venue with a capacity for 2000 people which will help to stimulate the evening economy</li> <li>Youth Enterprise Business Centre – working with the private sector to acquire and renovate a building into smaller units to provide an opportunity for young people working out of Primrose Hill Business Centre to showcase and sell their products</li> </ul>	
It was noted that quality is vital to the success of the Town Centre and a number of options to reconfigure the high street are being looked at, along with the possibility of public vehicles and parking on the high street. It was noted that traffic modelling is being looked at and the impact different models would have on the town centre. Members were informed that Stockton Borough Council are working with the owners of the Castlegate Centre and Wellington Square to look at sites for where a supermarket or an anchor store may be located to increase footfall. It was noted that £52,000 has been awarded from the Department of Communities and Local Government (DCLG), which is being used to support a number of projects and will compliment the work the Council is already doing to support local businesses and entrepreneurs make the most of opportunities in the Town Centre.	
<ul> <li>The money will be used to improve the look and feel of the Town Centre by reviving empty spaces left vacant by shops hit by the financial downturn. The Council is also planning a series of projects and events with the funding to encourage shoppers and visitors into the town. These include: <ul> <li>Holding more Town Centre events throughout the year - building on the success of recent events such as the Festafall film extravaganza, Take to the Tees and Stockton's International Riverside Festival;</li> </ul> </li> </ul>

It was noted that number of shops have closed recently, including Ethel Austin and decisions on closures are often made outside of the area/region. It was recognised that the market is very important and is celebrating the 700 <sup>th</sup> Anniversary of the Charter. There will be lots of events throughout the year which will be branded with the 700 <sup>th</sup> anniversary logo.	
Members were informed that the Shambles was refitted 2 years ago as a specialist food unit but was unsuccessful. A change of use has been granted and the Town Centre Manager is currently encouraging a number of businesses, especially start up businesses, to establish themselves in the Shambles. The Tourist Information Centre will also move into the Shambles by the end of March 2010.	
More is being done to improve the appearance of empty units by putting up pictures, however it was noted that it is often difficult to get the keys to access these units from the owners, as many live outside of the area.	
It was noted that Stockton Borough Council are working closely with retailers and have a Retail Forum. The Forum is currently working with Officers to develop a website and to improve their marketing and links with Stockton Borough Council and its festivals.	
It was discussed that Stockton Borough Council's Heritage Officer is working with owners to being forward renovation works to improve the outside and inside of buildings. <ul> <li>The specialist area for the proposed Stockton North Academy is science with health being the focus. NHS Stockton-on-Tees are the only NHS lead sponsor of an academy in the country. The academy will focus on issues of prevention and health education.</li> <li>The academy will be at the heart of the community and the facility will be available for the wider public to use</li> <li>The academy is also in partnership with Stockton Riverside College, Stockton Sixth Form College and Stockton Borough Council to ensure that the Academy is successful</li> <li>The proposed Stockton North Academy will bring together Blakeston and The Norton Schools</li> <li>It was noted that the key aims for the Academy is to promote health and well being, reduce inequalities for children and young people, make the academy the schools of choice, improve academic attainment and encourage young people to stay in learning post 16.</li> </ul>

for staff, pupils and parents and targeted consultation has taken place with pupils in school, along with a number of consultation events across a number of venues.	
<ul> <li>The following discussion points were raised:</li> <li>It was suggested that the current staffing model was not right and that staff were unsure if they would have a job at the new academy. It was noted that the sponsors are in discussions with Stockton Borough Council HR advisors</li> <li>It was noted that the teachers unions have signed up to the consultation</li> <li>There was a discussion regarding bus fares for children travelling to the academy from Primrose Hill. It was noted that this has not been raised during the consultation and no decision has been made regarding funding for transport arrangements for the schools</li> </ul>	No
<ul> <li>It was noted that for an interim period, young people may have to continue to go to both sites and transport arrangements will be looked at for this</li> <li>It was felt that it was surprising that a Principal Designate (PD) has not already been appointed in order to have leadership and a leadership team in place. It was noted that it is hoped that the PD will be appointed by Easter so that they are in place</li> </ul>
