Drug Related Offending

Members were provided with a presentation on Reducing Drug Related Offending. Statistics were provided on the age profile of those in treatment, gender, ethnicity, substance of choice. Information was provided on wrap-around issues such as employment and housing.

In 2009/10, 47 were sent to detox or rehab. In 2010/11 the number that were in treatment throughout the year was 1409.

The Key priorities were:-

- Housing
- Employment and Training
- Successful Exits
- Women
- Criminal Justice
- Harm Reduction
- Recovery Outcomes

Issues for the future were highlighted, such as:-

- Move to Public Health
- Removal of ring-fencing on budget
- Police and Crime Commissioners
- Continuation of Drug Recovery Wing based around IOM
- Payment by Results

Members held discussion on the presentation. It was reported that the 30-34 age group was the largest category for first time entrants into treatment. Heroin was the primary substance, however there was an increase in clients accessing steroid use. Discussion was held on unemployment being a contributory factor leading to people taking drugs and committing crimes to feed their habit. Many may not have a home to go to when released from prison and the Government was proposing to reduce tenancy rights. There will also be changes in the benefits system. This may need to be considered at a future meeting to discuss the implications.

Public health funding may be ringfenced but not around drugs and would need to determine priority based on needs assessment. Emma Champley will draft a letter to the two MP's highlighting Members concerns.

1. The presentation be noted.
2. An update be provided on any Government changes to Housing.
3. A letter be sent to the MP's highlighting concerns around public health funding issues.
