A question was raised as to where the 25% cuts will be made from, and it was explained that some of this will come from reduction in staffing at the centres, as well efficiencies through using the buildings with partners as well as options for getting more use out of the buildings.	
A further question was asked about a partnership model and would be of interest to other agencies, it was felt that the buildings would be of interest to other partners or individuals so long as it was not going to be used to provide services as another type of childrens centre.	
With regard to the delivery of services the point was raised that if the main centre was to be on Thornaby Road then people in central Stockton would find it difficult to access services, Beccy confirmed that 2 centres are to be kept in central Stockton and she was open to suggestions for buildings that could be used for Children's centre.

5. Welfare Reform Update	
Julie Higgins provided an update on the proposals on Housing Benefit Reform for Supported Housing and who will be affected by these changes.	
It was explained that the change was necessary as the rules are very complex and the Government wishes the rules to be more simplistic but also provide a flexible system that can better target those who most need help, at the moment rules vary according to clients care and support needs. There also needs to be compatibility with Universal Credit in the future and the cost to local authorities is high.	
Changes will affect people in conventional supported housing such as the elderly, ex-homeless, young people, substance misusers who have use of personal rooms with shared facilities, also affected are people with more

specific housing needs who need more intensive levels of personal care and support.	
Proposals for people in conventional supported housing include a flat rate addition to the LHA rate and meeting the additional costs by alternative funding streams or from other resources available to the client. Proposals also include a separate rate for different types of accommodation to reflect their costs or to base any addition on actual costs, Private Sector housing would also be included in the new rules. For people with more specific housing needs the proposals include meeting the additional housing costs based on LHA levels plus Supported Housing fund, the fund to be administered by the local authority but decisions to be taken away from housing benefit service; funding of supported housing to be brought within local authorities broader responsibility of commissioning care and support.	
A question was asked as to how the changes will impact on people living in Stockton and Julie responded by telling the group that more clarity on proposals of service charges and what will be paid for is necessary, issues will be whether people will need to apply for funding and will they actually apply. A further question was asked as to when the guidance will be available, and what it will mean to residents of sheltered housing in Stockton. Julie's response was that there is not enough information in the present guide to confirm and we do not want to create unnecessary concern or fear in elderly/vulnerable people. Linda Stephenson gave a presentation on Localising Support for Council Tax in England to the partnership. Items covered related to why support is to be localised and this included giving local authorities a greater stake in the economic future of their area, opportunity to reform the system of support for working age claimants and a degree of control over the impact of the 10% reduction, also to reinforce local control over council tax.	
Linda explained that the principles of the scheme were that local schemes should support work incentives and in particular avoid dis incentives to work, that there would be no change in the level of awards for pensioners and in particular that it is a local authority's duty to run a scheme to provide support for council tax in their area. It was also explained that it was expected that joint working between authorities will be encouraged when calculating administrative funding. Local authorities are free to configure services as they see fit but level of consistency between schemes must reflect the key points of universal credit. The timetable for the implementation of local schemes to be in operation is by the Spring of 2013 which means that there is only 6 months between regulations and start of scheme. The options of how savings can be made were outlined and explanations given

of those protected from any extra charges, and a suggestion that people who currently make no payment towards council tax will have to pay in order to meet the 10% saving required. Other discounts such as single person discount not included in consultation although consideration will be given to requesting a 20% minimum charge for working age claimants in order to meet the savings target. Issues around these charges are that 75% of council tax claimants also receive housing benefit and the housing benefit restrictions will impact on the ability for them to pay a contribution. At present both benefits are administered together but a separate council tax benefit scheme will increase admin costs.	
A question was asked around the proposals that there are to be no increase in charges for present pensioners and future pensioners but how long would this be for? Linda explained that this had not been stipulated at the moment.	
A further question was asked about unringfenced funding and what sort of evidence will be accepted to get the required funding, Linda explained that the government will look at what benefits were paid in a previous year and will estimate from that.
