

## Council Tax Resolution

A. Members are invited to **Recommend** that:

1. The Council calculated as its Council Tax Base for the year, in accordance with Section 31B (3) of the Local Government Finance Act 1992, as amended (the Act), and reported to the Leader and Cabinet Member for Corporate & Social Inclusion on 24 January 2013.

a) the amount calculated by the Council in accordance with Section 31B, as its Council Tax Base for the year: **49,667.96**

b) the amounts calculated by the Council as the amounts of its Council Tax Base for the year for dwellings in those parts of its areas to which one or more special items relate.

1. Each year the Secretary of State in accordance with Section 52 Local Government Finance Act 1992 will determine a limit for council tax rises. If an authority proposes to raise taxes above this limit they will have to hold a referendum to get approval from local voters.
2. The limit for council tax rises applicable to the authority as set by the Secretary of State for 2013/14 is 2.0%.
