<b>4. Matters Arising</b>  Suzanne Fletcher gave an update on the status of the Housing and Neighbourhood Partnership on the Stockton Asylum Seeker Multi Agency Forum. A letter has been written to Jomast to ask them to re-consider the decision to withdraw the partnership's invite to the forum.	
<b>5. Community Energy Saving Programme</b>  Mike Chicken, Built & Natural Environment Manager, Stockton Council, updated the partnership on the Community Energy Saving Programme, which commenced in 2008 and ended at December 2012. The programme targeted areas of low income by focussing on the 10% most deprived Lower Super Output Areas in the country. There were 17 areas in the borough that met this criteria. The programme was not means tested and eligible measures included external wall and cavity wall insulation, boiler replacements, heating controls, fuel switching and new heating systems.  A DVD that has been produced to showcase the success of the programme in Stockton was shown. A number of questions on the following issues were asked, including: Noise – Compensation for noise wasn't offered. The render is easily cleaned and it is hoped that it will contribute to a reduction in crime in these areas. Green deal finance – The Council has not joined the regional approach being taken on this. There are still a number of concerns that the Council has over how the deal will work in practice. Social Value – Is the Council looking to evaluate the social value impact of the scheme e.g. Reduction in hospital admissions, what households are using the money for that they save etc. There will be some research carried out at the end of March. <p><b>6. Empty Property Update</b></p> <p>Lesley Conroy, Coast and Country Housing, gave an update on their role in the Empty Homes Project in the borough. It was anticipated that by the end of March 2013 20 units of accommodation ranging from 1 bed self-contained flats to 5/6 bedroom houses will have been brought back into use.</p> <p>Lesley gave a brief explanation of the scheme. It was noted that there had been hesitancy from some landlords despite being offered up to £20,000 per property to bring it back into use and for a registered provider to manage the property for a minimum of 5 years.</p> <p>The Housing Options service is offered nominations for the properties to assist housing need in the borough.
