# NEW PROCEDURES FOR THE NOMINATION / APPOINTMENT OF LOCAL AUTHORITY GOVERNORS TO MAINTAINED SCHOOLS AND ACADEMIES

#### 1. Summary

This report proposes a procedure for nominating Local Authority Governors to serve on school governing bodies that have reconstituted under The School Governance (Constitution) (England) Regulations 2012. This procedure (Appendix 2) needs to be agreed by Members as the accepted protocol for the process.

The report also recommends an addition to the current Local Authority Governor appointment procedure (Appendix 1), to formalise the inclusion of the appointment of Local Authority Governors to Academies, as and when required.

#### 2. Recommendations

- 1. That the new procedure for nominating Local Authority Governors to reconstituted governing bodies is adopted (Appendix 2).
- 2. That the appointment of Local Authority Governors to Academies is included in the current appointment procedure (Appendix 1).
- 3. Consultation to be undertaken with Governing Bodies to develop outline guidance on the criteria that they may wish to use when requesting nominations for LA Governor representatives.

#### 3. Reasons for the Recommendations/Decision(s)

The School Governance (Constitution) (England) Regulations 2012 came into force in September 2012. The regulations are permissive, and in relation to Local Authority Governors will be applicable to schools who reconstitute after 1 September 2012.

The recommendations will provide a clear procedure for the nomination of Local Authority Governors to reconstituted governing bodies and similarly confirm the appointment procedure for Local Authority Governors to Academies.

#### 4. Members' Interests

Members (including co-opted Members) should consider whether they have a personal interest in any item, as defined in **paragraphs 9 and 11** of the Council's code of conduct

and, if so, declare the existence and nature of that interest in accordance with and/or taking account of **paragraphs 12 - 17** of the code.

Where a Member regards him/herself as having a personal interest, as described in **paragraph 16** of the code, in any business of the Council he/she must then, **in accordance with paragraph 18** of the code, consider whether that interest is one which a member of the public, with knowledge of the relevant facts, would reasonably regard as so significant that it is likely to prejudice the Member's judgement of the public interest and the business:-

- affects the members financial position or the financial position of a person or body described in **paragraph 17** of the code, or
- relates to the determining of any approval, consent, licence, permission or registration in relation to the member or any person or body described in paragraph 17 of the code.

A Member with a personal interest, as described in **paragraph 18** of the code, may attend the meeting but must not take part in the consideration and voting upon the relevant item of business. However, a member with such an interest may make representations, answer questions or give evidence relating to that business before the business is considered or voted on, provided the public are also allowed to attend the meeting for the same purpose whether under a statutory right or otherwise **(paragraph 19** of the code**)**.

Members may participate in any discussion and vote on a matter in which they have an interest, as described in **paragraph18** of the code, where that interest relates to functions of the Council detailed in **paragraph 20** of the code.

#### **Disclosable Pecuniary Interests**

It is a criminal offence for a member to participate in any discussion or vote on a matter in which he/she has a disclosable pecuniary interest (and where an appropriate dispensation has not been granted) **paragraph 21** of the code.

Members are required to comply with any procedural rule adopted by the Council which requires a member to leave the meeting room whilst the meeting is discussing a matter in which that member has a disclosable pecuniary interest (paragraph 22 of the code).

NEW PROCEDURES FOR THE NOMINATION / APPOINTMENT OF LOCAL AUTHORITY GOVERNORS TO MAINTAINED SCHOOLS AND ACADEMIES

#### SUMMARY

This report proposes a procedure for nominating Local Authority Governors to serve on school governing bodies that have reconstituted under The School Governance (Constitution) (England) Regulations 2012. This procedure (Appendix 2) needs to be agreed by Members as the accepted protocol for the process.

The report also recommends an addition to the current Local Authority Governor appointment procedure, to formalise the inclusion of the appointment of Local Authority Governors to Academies, as and when required. (Appendix 1)

#### **RECOMMENDATIONS**

- 1. That the new procedure for nominating Local Authority Governors to **reconstituted governing bodies** is adopted (Appendix 2).
- 2. That the appointment of Local Authority Governors to Academies is included in the current appointment procedure. (Appendix 1)
- 3. Consultation to be undertaken with Governing Bodies to develop outline guidance on the criteria that they may wish to use when requesting nominations for LA Governor representatives.

#### **DETAIL**

- 1. In September 2012, The School Governance (Constitution) (England) Regulations 2012 came into force. As the regulations are permissive, it is not a requirement for governing bodies to reconstitute. All schools therefore may continue to operate under their current Instrument of Government and appoint to vacancies under the current existing arrangements. However, if they wish to alter any aspect of their current Instrument of Government, e.g. size; composition; term of office or change the name of the school, then they must adhere to the new regulations. Governing bodies of new schools constituted after 1 September 2013 would automatically be constituted in accordance with the new regulations.
- 2. Local Authorities will therefore need to apply two systems to run in parallel when dealing with the appointment/nomination of Local Authority Governors. The current procedure for existing constituted governing bodies (Appendix 1) and the new proposed procedure for nomination for schools that reconstitute or are new schools (Appendix 2).

- 3. The existing procedure for identifying and appointing Local Authority representatives to governing bodies is detailed at Appendix 1. This procedure was approved by Cabinet in March 2000.
- 4. The proposed procedure for newly constituted governing bodies from September 2012 and new schools is detailed at Appendix 2.
- 5. Maintained school governing bodies constituted under an instrument taking effect on or after 1 September 2012 and existing governing bodies that have varied their instrument since that date, must be constituted under the School Governance (Constitution) (England) Regulations 2012. There regulations provide that the minimum size of the governing body is seven members and the governing body must include:
  - at least two parent governors
  - the headteacher, unless the headteacher decides not to be a governor
  - only one staff governor
  - only one LA governor; and
  - foundation governors or partnership governors as specified in the regulations
- 6. For information attached at Appendix 3 is a list of schools and the details of current LA governor representatives and vacancies within this category.

# PROCEDURE FOR THE APPOINTMENT OF LOCAL AUTHORITY GOVERNORS TO SCHOOL GOVERNING BODIES (CURRENT PROCEDURES)

Based on legislation detailed in the 1996 Education Act and subsequent amendments, the Local Authority has a duty to appoint representatives to serve as governors on the Governing Bodies of all schools maintained by them. The report to Cabinet on 11 March 2000 (minute 84) approved the current procedures for appointing Local Authority representatives to serve on school Governing Bodies. This procedure is:-

- 1. Any vacancy identified pertaining to a Local Authority Governor will be notified to the Local Authority (Director of Children, Education and Social Care); to all Party Secretaries and to all schools requesting nominations.
- 2. Nominations will be received against an identified closing date and this information will be detailed on the Cabinet report and forwarded to Democratic Services.
- 3. Report goes to pre-agenda meeting and subsequently Cabinet meeting.
- Cabinet decision informed to School and Governor Support Service and prospective governor notified and requested to complete declaration form and relevant checks carried out.
- 5. Subject to all checks being satisfactory the appointment is confirmed and the governor notified.

# PROCEDURE FOR THE NOMINATION AND APPOINTMENT OF LOCAL AUTHORITY GOVERNORS ON SCHOOL GOVERNING BODIES (APPLICABLE TO SCHOOLS THAT HAVE RECONSTITUTED SINCE SEPTEMBER 2012 AND NEW SCHOOLS)

Under powers vested in them by The Education Act 2011, Part 5, Paragraph 38, Section 4a, the Local Authority has a duty to nominate representatives to serve as governors on the Governing Bodies of all schools who have reconstituted under The School Governance (Constitution) (England) Regulations 2012.

#### The procedure is:-

- 1. The Governing Body of the said school, if having reconstituted, will inform the Local Authority (Director of Children, Education and Social Care) of a vacancy on the Governing Body for a Local Authority representative and will include the eligibility criteria applicable to the vacancy. (Part 2, section 8, of the 2012 Regulations).
- 2. The vacancy, along with the eligibility criteria, will be notified to all Party Secretaries, all schools and any other stakeholders requesting nominations.
- 3. Nominations when received in line with prescribed deadlines will be detailed on the Cabinet report and uploaded, via Democratic Services, to E-genda, in advance of the pre-agenda meeting.
- 4. Each nomination will be considered against the individual governing body's eligibility criteria and preferred nominee(s) approved.
- 5. Where a nomination has been approved by Cabinet, this will be forwarded to the Governing Body for consideration and approval. It is for the Governing Body to decide whether the nominee meets their eligibility criteria, and therefore confirm the appointment.
- 6. The relevant checks will be carried out in accordance with statutory requirements.
- NB: In the absence of any written nominations the vacancy will be automatically referred to the next Cabinet meeting.
