10/13**      **Troubled Families - Year 1 Review**

Members were provided with a copy of a report that was due to go to Cabinet on 13th June 2013.

The report provided an outline of the progress achieved during the first year (April 2012 to March 2013) of delivering the 'Troubled Families' programme in Stockton, and made proposals for the delivery of the remainder of the programme.

The report requested that Cabinet consider the following recommendations:-

1. That the delivery of the programme be extended for a fourth year, subject to satisfactory performance and to the availability of funding within the 'Troubled Families' budget.
2. That a further report be submitted during 2014/15 examining in more detail the case for continuing funding from the Council's 'Invest to Save' budget to a continuation of the programme beyond 2015/16.

Members held discussion on the report and requested an update once the report had been considered by Cabinet.

AGREED that the report be noted and that an update be provided following the Cabinet meeting on 13th June 2013.

11/13**      **Recorded Crime & Disorder**

Members were provided with the recorded crime and anti-social behaviour figures for April 2012-March 2013 compared to the same time period in 2011/12.

At the end of the financial year, total recorded crime had reduced by 3.9%, equating to 453 fewer victims of crime. This included both public reported and police generated crimes.

It was reported that there were a small number of prolific offenders within Stockton. It was stated that Durham University was carrying out research on shoplifting and Members would be keen to see their report.

Discussion was held on the night time economy in Yarm and the increase in anti social behaviour etc.

14/13**      **Monitoring Report for Alcohol Strategy/Action Plan**

The Stockton-on-Tees Alcohol Strategy was implemented in April 2010. The Strategy was a 3 year Strategy with a 2 year Action Plan within it. The 1 year plan for 2012-2013 had been developed to ensure that the strategic aims of the Stockton-on-Tees Alcohol Strategy were continuously achieved. This plan had the needs of young people threaded throughout it as opposed to a separate section (as was within previous plans). This plan covered responsibilities across both adults and children's services.

Members were provided with an update on alcohol related domestic violence. It was noted that 532 intervention letters had been sent to parents regarding their child being found in possession of alcohol.

A new action plan was currently being developed. Jo Heaney would provide members with an end of year summary at the next meeting.

17/13**      **Community Safety Audit 2013**

Members were provided with a working copy of the information document that was being prepared to form the basis of the Community Safety Magazine which would be going out to all residents at the end of August 2013.

Members were requested to note in particular the crime and ASB statistics that were planned to be used as part of the document as well as the first draft of the questionnaire for residents to complete.

Members queried whether the ward comparator information was meaningful to members of the public as there were many factors that could affect the results such as night-time economy etc.

A copy of the suggested questionnaire was circulated for information. Members were requested to email further comments and/or suggested changes to Steven Hume.

AGREED that the update and comments be noted and that this report be brought back to future meetings.

18/13**      **Community Safety Fund 2012/13 - Performance**

The Community Safety Fund (CSF) was the only funding controlled by the Partnership in 2012/13. The total Stockton allocation was approximately £103k which was 'topliced' by approximately £19k, reflecting the historical ringfenced allocation for young people's substance misuse services, leaving approximately £84k for allocation by the Partnership.

Members were provided with the performance outcomes for the work of the IOM team for 2012/13, and two of the key targets in relation to Domestic Violence Services were included in the Community Safety Plan monitoring report, a further report on domestic violence was distributed at the meeting.

AGREED that the report be noted.

20/13**      **Reducing Reoffending**

Members were provided with the interim report prepared by the joint ANEC/NOMS project.

The report raised a series of issues for community safety partnerships, and for colleagues responsible for a range of services including at least housing supply/re-housing, drugs and alcohol misuse, offender health and work with children and families, and the agenda around adults with multiple and complex needs. In this last respect, it was noteworthy that the Tees Valley bid to Big Lottery Fund's 'Fulfilling Lives – Multiple and Complex Needs' programme was unsuccessful, despite very positive feedback at the initial bidding stage.

Stockton, in common with other localities, was participating in the 'common offer' approach to the 'Troubled Families' programme.

A further report would be provided in June, 2013.

AGREED that the report be noted and that a further report be presented at the next meeting.

21/13**      **CSP Funding 2013/14**

Following the election of the Police and Crime Commissioner (PCC) in November 2012, funding that was previously allocated to the partnership by the Home Office was transferred under the new arrangements.

All four Community Safety Partnerships were required to submit a business case for funding. A business case was submitted on behalf of the partnership outlining the key priorities for funding and this had since been approved by the Police and Crime Commissioner.

Members were provided with a table that outlined the allocation for Stockton for 2013/14 along with the agreed performance measures which would be reported back to the Commissioner on a quarterly basis.

AGREED that the Funding for 2013/14 be noted.

A public opinion survey of satisfaction with local authority services and associated issues was undertaken on behalf of seven of the twelve North East local authorities by Ipsos MORI between June and August 2012.

The headline results were reported to the Partnership at its meetings of 18 December 2012 and 5 February 2013. The key finding was that the results for our Borough compared extremely favourably with the average of results.

Further detailed comparator information had now been made available and was provided to Members.
