# 1. Summary

The attached consultation document including appendices and maps outlines the admission arrangements the Local Authority (LA) is proposing for primary and secondary schools in September 2016. In order to comply with legislation for admissions in 2016, this consultation document includes the full Co-ordinated Admission Arrangements and Admission Numbers for Primary and Secondary Schools for that year in addition to two priorities focussing on:

- (i) The proposed admission zones changes to primary schools in Ingleby Barwick
- (ii) The proposed admission zone changes to secondary schools in the South of the Borough

# 3. Reasons for the Recommendations/Decision(s)

Legislation requires the LA to publish information to be available for parents when they apply for a place at primary and secondary school. The information has to comply with the published 2012 School Admissions Code. The LA is required to set admission arrangements accordingly and lodge a copy of the Co-ordinated Admission Arrangements with the Secretary of State by the 15 April 2015 for admission to Primary and Secondary schools in September 2016.

# 4. Members' Interests

However, a member with such an interest may make representations, answer questions or give evidence relating to that business before the business is considered or voted on, provided the public are also allowed to attend the meeting for the same purpose whether under a statutory right or otherwise **(paragraph 19** of the code**)** 

Members may participate in any discussion and vote on a matter in which they have an interest, as described in **paragraph18** of the code, where that interest relates to functions of the Council detailed in **paragraph 20** of the code.

# **Disclosable Pecuniary Interests**

It is a criminal offence for a member to participate in any discussion or vote on a matter in which he/she has a disclosable pecuniary interest (and where an appropriate dispensation has not been granted) **paragraph 21** of the code.

Members are required to comply with any procedural rule adopted by the Council which requires a member to leave the meeting room whilst the meeting is discussing a matter in which that member has a disclosable pecuniary interest (**paragraph 22** of the code)

# **DETAIL**

# 1. The proposed changes to the School Admissions Code

The Department for Education (DfE) is considering revising the School Admissions Code 2012 (the Code) and the relevant accompanying regulations. The overarching aim is to improve the fair and open allocation of places in maintained schools and academies, and to support social mobility by allowing admission authorities to give priority for school places to disadvantaged children. This Code comes into force on **19 December 2014**. It will apply to admission arrangements determined in 2015 for admission in school year 2016/17. In practice, this means the LA could consider giving priority in their oversubscription criteria to children eligible for early years, pupil and service premium funding.

Note: After careful consideration the LA proposes <u>not</u> to take pupil and service premium into account within the oversubscription criteria for September 2016 admissions. However, this will be considered as part of phase 2 of the Review process.

We can also reassure Cabinet Members that in terms of children of UK Armed Forces service personnel, the LA fully complies with both the Admissions Code 2012 and the Admissions to Schools in England and the Armed Forces' Covenant in relation to maintained community schools.

In addition, the DfE propose to make the following minor changes which would:

- Revise the timetable for admission arrangements
- Bring forward dates for admission authorities to consult on their arrangements
- Clarify the provision relating to the admission of summer born children to aid decisionmaking
- Make clear that the highest priority for admission applies to all children who been adopted from local authority care

The LA will adhere to the above revisions to the timetable as detailed in the DfE 'Changes to the School Admissions Code' document and apply with immediate effect were stated. Details can be found in the Consultation document – **Appendix A**.

# 2. The proposed Co-ordinated Admissions Scheme for Primary, Secondary, Voluntary Aided (VA) schools, Academies and Free School

The LA is responsible for administering a co-ordinated scheme for its area in relation to all maintained (community, voluntary controlled and voluntary aided) schools. The purpose of co-ordinated admission scheme is to ensure that, as far as is reasonably practicable, every parent of a child living in the LA area who has applied for a school place in the normal admission round receives an offer of one school place on the same day.

The LA plans to roll forward last year's co-ordinated scheme for 2016/17 apart from date changes for the timetables. A copy of the agreed scheme must be determined with our other admission arrangements by 15 April and will be available before 1 May and copies can be obtained from the Admissions Section on request or when the 2016/17 arrangements are approved, can also be viewed on the Stockton on Tees website <a href="www.stockton.gov.uk">www.stockton.gov.uk</a> Appendix 1.

# 3. The proposed admission numbers for Primary and Secondary schools for September 2016

Details can be found in the Consultation document – **Appendix A**.

**Appendix 2** gives the proposed Admission Numbers for September 2016 in Community, VA, Academies and Free School and shows the proposed increase in school admission numbers across the Borough.

# 4. The proposed admission zone changes to primary schools in Ingleby Barwick

The current arrangement in Ingleby Barwick for primary school zones is reflected in 'Map 1-Existing Primary Admission Zones in Ingleby'. The map shows the area split into the following zones:

- 1. St Francis of Assisi CE Primary
- 2. Whinstone Primary
- 3. Ingleby Mill Primary
- 4. Myton Park Primary

with Barley Fields Primary operating across the whole of Ingleby Barwick and St Therese of Lisieux Primary adopting their ecclesiastical parish, which includes the whole of Ingleby Barwick.

Since the existing zonal arrangements were agreed, St Francis of Assisi CE Primary has increased in size and is now operating across their ecclesiastical parish which also includes the whole of Ingleby Barwick.

In addition, it was felt that due to the additional school places now available at both St Francis of Assisi CE Primary and Barley Fields Primary, it was important that the existing admission zones were reviewed to enable the following:

- 1. The 2 faith schools of St Francis of Assisi CE Primary and St Therese of Lisieux Primary to be accepted as operating across the whole of Ingleby Barwick as part of their associated parish arrangements.
- 2. The remaining four maintained community schools of Whinstone Primary, Ingleby Mill Primary, Myton Park Primary and Barley Fields Primary to have clearly defined admission zones which cover the Ingleby Barwick area.
- 3. That consideration is given to both existing and new approved housing developments and the associated new roads and subsequent traffic implications.

The LA undertook some local consultation with the affected schools, their governing bodies and interested parents. In addition, the proposals were also shared with Ingleby Barwick Councillors to gain their views. As a result of this work the original plans were amended to reflect local opinion and those proposed new arrangements can be found in 'Map 2 Proposed Primary Admission Zone Changes in Ingleby Barwick.'

# 5. The proposed admission zone arrangement for secondary schools in the South of the Borough

Current secondary school arrangements for the South of the Borough - In addition to the three existing schools of All Saints CE Academy, Conyers School and Egglescliffe School offering 599 school places, a new Free School in Ingleby Barwick (Ingleby Manor Free School & Sixth Form) added an additional 120 places to the secondary main round offer. St Patrick's Catholic College also offer 111 faith places to residents within the area.

The opening of the Free School, albeit at a temporary site with a view to a permanent move at Maltby Farm, was positive and increased the number of places available particularly to Ingleby Barwick residents.

In addition, demand for places at Egglescliffe School continues to be high and significantly exceed those available. As new housing developments come on line, demand for places in Egglescliffe from local ward residents is likely to increase.

Therefore, consideration needed to be given to the overall places available as a result of the opening of Ingleby Manor Free School & Sixth Form, particularly to Ingleby Barwick residents. As part of this process and taking into account the growing demand for places at Egglescliffe School, a decision was made to review the existing arrangements.

Please note, the following schools are responsible for setting their own admission zones and arrangements:

- 1. Convers School
- 2. All Saints CE Academy
- 3. Ingleby Manor Free School and Sixth Form
- 4. St Patrick's Catholic College

Within the south of the borough, the LA continues to be the Admission Authority for Egglescliffe School only.

## **Proposal**

The existing admission zone boundaries for all South Stockton secondary schools will be retained.

However, the LA proposes to amend the current arrangements when applying its oversubscription criteria for Egglescliffe School for a place in September 2016. It is proposed that the LA will apply the equal ranking system by initially processing applications from those that reside in Zone A. The system will rank any remaining places available from residents in Zone B. Details of the zones are as follows:

- Zone A all applicants living in Eaglescliffe ward and the western parish villages of Carlton, Redmarshall, Elton and Long Newton; and
- Zone B Ingleby Barwick 'villages' namely the Rings and in part Broom Hill.

Maps are attached to identify Zone A and Zone B within the Egglescliffe School overall admission zone boundary.

# 6. The proposed Admission Policy for September 2016

It is proposed that no changes will be made to the current 2015/16 admission policy for admissions for 2016/17 and which relate to the schools where the LA is the Admissions Authority.

Therefore the proposed Admission Policy for 2016/17 will give priority to applications for admission to a school if that school is oversubscribed, in the document attached at **Appendix 3**.

The proposed criteria will be available in the LA's published booklet for parents 'Primary and Secondary Admissions 2016 Guidance Booklet.'

# 7. Increase in the number of places at Ash Trees Primary School for September 2015 from 124 to 150

Following the conclusion of the 4 week 'Representation' period (Stage 2 of the Statutory Process) the LA has approved the decision to increase the number of school places at Ash Trees Primary School from 124 to 150 to accommodate the increase in demand of children with Special Education Needs (SEN) and disabilities. There were 3 meetings held with parents of the school and only 5 responses received within the consultation period of the 1<sup>st</sup> to the 28<sup>th</sup> October 2014.

# 8. The LA approach to Primary places for north/central Stockton

It is intended to retain current PANs for 2016 across the 23 schools in the above primary planning area. Frederick Nattrass Primary Academy, part of the Northern Education Trust (NET), is to consult on increasing its PAN to 40 from 30. We will also expect the proposed new Church of England Free School in Wynyard to open as early as September 2015 adding a further 60 Reception places. We will however look to increase the admission numbers in a small number of schools through discussion with Head teachers / Principals and Governing bodies to provide some additional capacity if demand dictates it. The outcome of a commissioned 'Capacity and Suitability' exercise involving a number of schools in these two planning area will assist in informing those decisions where required.

# 9. FINANCIAL IMPLICATIONS

The cost relating to the admissions arrangements have been included in the Council's Medium Term Financial Plan.

The framework for admissions was introduced in the School Standards and Framework Act 1998 but a number of important changes were implemented through the Education Act 2002 and the Education and Inspections Bill 2006. The new School Admission Code published in February 2012 takes account of those changes, and of associated regulations. The consultation and information within this report complies with the relevant legal requirements.

#### 10. LEGAL IMPLICATIONS

Legislation requires the LA to publish information to be available for parents when they apply for a place at primary and secondary school. The information has to comply with the published 2012 School Admissions Code. The LA is required to set admission arrangements accordingly and lodge a copy of the Co-ordinated Admission Arrangements with the Secretary of State by the 15 April 2015 for admission to Primary and Secondary schools in September 2016.

The proposals contained within this report comply with relevant statutory requirements.

## 11. RISK ASSESSMENT

A risk assessment will be completed following the end of the statutory consultation period prior to the updated Cabinet Paper due 12th March 2015.

In order to comply with the Schools Admissions Code 2012, the LA is required to formally consult on any changes to its admission arrangements for a period of 8 weeks, between the 1<sup>st</sup> November and the 1<sup>st</sup> March.

It is therefore, planned that the formal consultation process will commence on 15<sup>th</sup> December 2014 and will conclude on 13<sup>th</sup> February 2015.

It is proposed that a number of public meetings will be held to give local parents the opportunity to express their views. The document will be available on-line and comments can be made either in writing, by e-mail or by completing a questionnaire through 'Survey Monkey'.

Results of informal consultation are included within the report, and full consultation with all Councillors consulted with will be included in the Cabinet report in March 2015.

CONSULTATION DETAIL ON THE ADMISSION ARRANGEMENTS FOR COMMUNITY, VOLUNTARY CONTROLLED PRIMARY & SECONDARY SCHOOLS IN STOCKTON-ON-TEES FOR SEPTEMBER 2016

#### 1. PURPOSE OF THIS CONSULTATION DOCUMENT

The purpose of this document is to provide information for Elected Members, Governing Bodies, and other Local Authorities, the Diocese, Parish Councils and parents on the proposed admission arrangements for community, voluntary controlled primary and secondary schools in Stockton-on-Tees for the school year 2016/17.

The School Admissions Code (the Code) came into force in February 2012, and applies to admissions to all maintained schools and Academies. The Code is made under section 84 of the School Standards and Framework Act 1998 as amended by section 40 of the Education and Inspections Act 2006. Admission authorities must ensure that their determined admission arrangements for 2015 comply with the mandatory provision of the Code. The Admission arrangements for Stockton on Tees, laid out in this report for 2016/17, are compliant.

Elected Members will consider the Local Authority's (LA) admission policy for 2016/17 and the co-ordinated admission arrangements for Stockton on Tees. In order that Members can take account of the views and opinions of Governors and others, comments are invited on the information raised in this paper. Any responses to this paper will be included in the final report to Cabinet in March 2015.

## 3. BACKGROUND

# Admission arrangements for 2016/17

To ensure equity and fair access, the Admissions Code 2012 states that in drawing up admission arrangements, admission authorities must ensure that the practices and the criteria used to decide on the allocation of school places are:

- clear in the sense of being free from doubt and easily understood
- objective and based on known facts. Admission authorities and Governing Bodies must not make subjective decisions or use subjective criteria
- procedurally fair and are also equitable for all groups of children and actively promote equity across all social groups and communities
- enable parents' preferences for the schools of their choice to be met to the maximum extent possible
- provide parents or carers with easy access to helpful admissions information
- comply with relevant legislation, including infant class sizes and equal opportunities, which have been determined in accordance with the statutory requirements

For applications in the normal admission round, the LA provides a common application form (CAF) that enables parents to express in order of preference a place at any state-funded school, with a minimum of 3 preferences in rank order, allowing them to give reasons for their preferences.

Within Stockton-On-Tees borough, parents of children who are resident within the admission zone of a particular school and who request a place at that school are given priority of a place.

While parents may express a preference for any state funded school – regardless of whether it is in the LA area in which they live, since September 2000 we do not guarantee parents preferences for a school place for pupils who live within the admission zone, if the school is full.

# 4. Changes to the School Admissions Code

The Department for Education (DfE) is considering revising the School Admissions Code 2012 (the Code) and the relevant accompanying regulations. The overarching aim is to improve the fair and open allocation of places in maintained schools and academies, and to support social mobility by allowing admission authorities to give priority for school places to disadvantaged children. This Code comes into force on **19 December 2014**. It will apply to admission arrangements determined in 2015 for admission in school year 2016/17. In practice, this means the LA could consider giving priority in their oversubscription criteria to children eligible for early years, pupil and service premium funding.

Note: After careful consideration the LA proposes <u>not</u> to take pupil and service premium into account within the oversubscription criteria for September 2016 admissions.

In addition, the DfE propose to make the following minor changes which would:

- Revise the timetable for admission arrangements to:
- Bring forward dates for admission authorities to consult on their arrangements:
  - Reduce consultation period from 8 to 6 weeks
  - Consultation must take place between 1 October and 31 January

- Therefore for arrangements which are to apply to applications in 2016 (entry in September 2017), consultation must be completed by 31 January 2016
- Bring forward the date for admission authorities to determine (formally agree) admission arrangements every year, even if they have not been changed from the previous year. Admission authorities must determine admission arrangements for entry in September 2016 by 15 April 2015 and for all subsequent years, by 28 February in the determination year.
- Once determined admission authorities must send a copy for entry in September 2016 as soon as possible before 1 May 2015 to the local authority, and for all subsequent years, as soon as possible before 15 March in the determination year.
- Local authorities must publish on their website the proposed admission arrangements for any new school or Academy which is intended to open within the determination year, details of where the determined arrangements for all schools, including Academies, can be viewed, and information on how to refer to the School Adjudicator. LA must publish these details in 2015 by 1 May 2015 and in all subsequent years by 15 March in the determination year.
- Require admission authorities to amend the admission arrangement to comply with the Code within two months of a decision of the School Adjudicator, where the Adjudicator rules the arrangements are unlawful. This will mean that all subsequent objections to admission arrangements must be referred to the Adjudicator by 15 May in the determination year instead by 30 June as is the current arrangement.
- Clarify the provision relating to the admission of summer born children to aid decisionmaking
- Make clear that the highest priority for admission applies to all children who been adopted from local authority care

The LA will adhere to the above revisions to the timetable as detailed in the DfE 'Changes to the School Admissions Code' document and apply with immediate effect were stated.

The LA is responsible for the coordination of school admissions for people who pay their Council Tax to Stockton-On-Tees Borough Council. This means that parents apply via Stockton LA, even if the school that they want is not in the Stockton area. We will liaise with our colleagues in neighbouring authorities and with the Voluntary-Aided (VA) schools, Academies and Free Schools in Stockton, to make sure all parents are offered a school place.

# 6. PROPOSED ADMISSION NUMBERS) FOR PRIMARY AND SECONDARY SCHOOLS FOR SEPTEMBER 2016

The LA receive pupil projections from Tees Valley Unlimited (TVU) annually which show a rise in the number of pupils within the primary sector, and the detail is laid out in the School Organisation Plan that was approved at Cabinet in November 2013. This demand is resulting in pressure for places in areas of the Borough, particularly in lower primary (Reception, Key Stage 1).

# **Primary**

In anticipation of this the LA completed a number of refurbishment works that took place across the borough which led to primary places, available for children entering Reception, increasing in September 2014 to 2,614.

For September 2015 it is expected that Primary reception places are to increase by a further 50 and will number 2,664. The following explains how this total has been arrived at:

• The Diocese of Durham Board of Education on the 30<sup>th</sup> September 2014 received approval from the DfE for their proposal to open a new two form entry Church of England Primary Free School to receive pupils in September 2015. The proposal is at the 'pre-opening stage' only and subject to the governing body receiving their Funding Agreement from the Secretary of State the school called 'Wynyard Church of England Primary School will open with a Published Admission Number (PAN) of 60. The LA Co-ordinates all applications for school place's on behalf of the proposed new school for entry into Reception for September 2015 and thereafter. The school is planned to be built in the north of the borough at Wynyard Village to help meet the expected demand for school places from both existing and planned housing developments in the area and it will increase the choice of school places in the North Stockton planning area.

• The Admission Authority, the schools Governing Body, consulted on their admissions arrangements for 2015-16 to reduce St Patrick's RC Primary School PAN from 40 to 30 for the September 2015 admission and therefore the school will continue to operate this PAN for September 2016.

For September 2016 it is expected that Primary reception places are to increase by a further 25 and will number 2,689. The following explains how this total has been arrived at:

- The Admission Authority the Northern Education Trust (NET) is consulting on behalf of one of its academies 'Frederick Nattrass Primary Academy' to increase the schools PAN to 40 from 30 in response to the demand for school places in the North Stockton planning area of the borough. The LA fully supports this increase and is line with the Statutory Requirements as per the 2012 School Admissions Code.
- Mandale Mill Primary, the LA community maintained school, rebuilding programme is anticipated to be completed late 2015 / early 2016. This will add a further 15 Reception places for September 2016 when the school re-opens. This will mean the schools PAN increases from 45 to 60 increasing the offer in the Thornaby planning area.

# Secondary

There is to be only one proposed change to Secondary School places from the 2,373 available for September 2015 Year 7 entry, and the following proposal would result in a reduction to 2,323 in September 2016. The following explains how this total has been arrived at:

• The Admission Authority the Northern Education Trust (NET) is consulting on behalf of one of its academies 'North Shore Academy' to decrease the schools PAN by 50 places from 210 to 160. This reduction is expected to be reviewed each Admission year to ensure the LA has sufficient school places for parents seeking Y7 school places post 2016. This proposed change is line with the Statutory Requirements as per the 2012 School Admissions Code.

**Appendix 2** gives the proposed Admission Numbers for September 2016 in Community, VA, Academies and Free School and shows the proposed increase in school admission numbers across the Borough.

# 7. THE PROPOSED ADMISSION ZONE CHANGES TO PRIMARY SCHOOLS IN INGLEBY BARWICK

The LA operates 'admission zones' where each school has its own defined area, and where parents live will determine their admission zone school. This provides parents with some priority within the LAs Admission Policy. Where there are more applications for a school than there are places available, places will be allocated using the oversubscription criteria. This does not affect a parent's right to ask for a preferred school but they would need to bear in mind how their circumstances fit into the policy (or policy for a VA school, Academy or Free School) as to whether they would gain a place at the preferred school, especially if the school has a history of being oversubscribed. It is also important to note that as the LA adopts an 'admission zone' policy, the concept of 'feeder' primary schools does not apply when allocating school places.

The current arrangement in Ingleby Barwick for primary school zones is reflected in 'Map 1-Existing Primary Admission Zones in Ingleby'. The map shows the area split into the following zones:

- (i) St Francis of Assisi CE Primary
- (ii) Whinstone Primary
- (iii) Ingleby Mill Primary
- (iv) Myton Park Primary

with Barley Fields Primary operating across the whole of Ingleby Barwick and St Therese of Lisieux Primary adopting their ecclesiastical parish, which includes the whole of Ingleby Barwick.

Since the existing zonal arrangements were agreed, St Francis of Assisi CE Primary has increased in size and is now operating across their ecclesiastical parish which also includes the whole of Ingleby Barwick.

In addition, it was felt that due to the additional school places now available at both St Francis of Assisi CE Primary and Barley Fields Primary, it was important that the existing admission zones were reviewed to enable the following:

- (i) The 2 faith schools of St Francis of Assisi CE Primary and St Therese of Lisieux Primary to be accepted as operating across the whole of Ingleby Barwick as part of their associated parish arrangements.
- (ii) The remaining four maintained community schools of Whinstone Primary, Ingleby Mill Primary, Myton Park Primary and Barley Fields Primary to have clearly defined admission zones which cover the Ingleby Barwick area.
- (iii) That consideration is given to both existing and new approved housing developments and the associated new roads and subsequent traffic implications.

The LA undertook some local consultation with the affected schools, their governing bodies and interested parents. In addition, the proposals were also shared with Ingleby Barwick Councillors to gain their views. As a result of this work the original plans were amended to reflect local opinion and those proposed new arrangements can be found in 'Map 2 Proposed Primary Admission Zone Changes in Ingleby Barwick.'

# 8. THE PROPOSED ADMISSION ZONE ARRANGEMENTS TO SECONDARY SCHOOLS IN THE SOUTH OF THE BOROUGH

Within Stockton-On-Tees Borough parents of children who are resident within a schools admission zone and who request a place at that school, are given priority of place. While parents may express a preference for any state funded school – regardless of whether it is in the LA area in which they live, since September 2000 we do not guarantee parents preferences for a school place for pupils who live within the admission zone, **if the school is full**.

# Current secondary school arrangements for the South of the Borough

In addition to the three existing schools of All Saints CE Academy, Conyers School and Egglescliffe School offering 599 school places, a new Free School in Ingleby Barwick (Ingleby Manor Free School & Sixth Form) added an additional 120 places to the secondary main round offer. St Patrick's Catholic College also offer 111 faith places to residents within the area.

The opening of the Free School, albeit at a temporary site with a view to a permanent move at Maltby Farm, was positive and increased the number of places available particularly to Ingleby Barwick residents.

In addition, demand for places at Egglescliffe School continues to be high and significantly exceed those available. As new housing developments come on line, demand for places in Egglescliffe from local ward residents is likely to increase.

Therefore, consideration needed to be given to the overall places available as a result of the opening of Ingleby Manor Free School & Sixth Form, particularly to Ingleby Barwick residents. As part of this process and taking into account the growing demand for places at Egglescliffe School, a decision was made to review the existing arrangements.

Please note, the following schools are responsible for setting their own admission zones and arrangements:

- (i) Conyers School
- (ii) All Saints CE Academy
- (iii) Ingleby Manor Free School and Sixth Form
- (iv) St Patrick's Catholic College

Within the south of the borough, the LA continues to be the Admission Authority for Egglescliffe School only.

# **Proposal**

The existing admission zone boundaries for all South Stockton secondaries will be retained.

However, the LA proposes to amend the current arrangements when applying its oversubscription criteria for Egglescliffe School for a place in September 2016. It is proposed that the LA will apply the equal ranking system by initially processing applications from those that reside in Zone A. The system will rank any remaining places available from residents in Zone B. Details of the zones are as follows:

- Zone A all applicants living in Eaglescliffe ward and the western parish villages of Carlton, Redmarshall, Elton and Long Newton; and
- Zone B Ingleby Barwick 'villages' namely the Rings and in part Broom Hill.

Maps are attached to identify Zone A and Zone B within the Egglescliffe School overall admission zone boundary.

# 9. PROPOSED ADMISSION POLICY FOR SEPTEMBER 2016 – Primary and Secondary Community and Voluntary Controlled (VC) Schools

It is proposed that no changes will be made to the current 2015/16 admission policy for admissions for 2016/17 and which relate to the schools where the LA is the Admissions Authority.

# **Proposed Admission Policy for 2016/17**

Therefore the proposed Admission Policy for 2016/17 will give priority to applications for admission to a school if that school is oversubscribed, in the document attached at **Appendix 3**.

The proposed criteria will be available in the LA's published booklet for parents 'Primary and Secondary Admissions 2016 Guidance Booklet.'

## 10. CONCLUSION

Within Stockton on Tees we aim to ensure that the admission arrangements are in line with the principle of fair access to educational opportunity. These proposed changes if agreed to the LA's current policies, procedures and the additional information will be published in the Primary and Secondary Admissions 2016 Guidance Booklet by 1 September 2015 and will be available to parents.

#### Introduction

1. The 1998 Act, as amended by the Education Act 2002, has introduced new statutory requirements for every Local Authority (LA) to draw up a scheme covering every maintained school in its area. Stockton-on-Tees LA has drawn up a full co-ordinated admissions scheme for the main rounds for Primary and Secondary applications and 'in year' transfer requests for the academic year 2015/16.

The scheme also complies with changes introduced to the new School Admissions Code through the Education & Inspections Bill 2006.

## Interpretation

#### 2. In this scheme:

"the LA" means Stockton on Tees Borough Council acting in their capacity as local education authority;

"the LA area" means the area in respect of which the LA is the local education authority.

"primary education" has the same meaning as in section 2(1) of the Education Act 1996;

"secondary education" has the same meaning as in section 2(2) of the Education Act 1996;

"primary school" has the same meaning as in section 5(1) of the Education Act 1996;

"secondary school" has the same meaning as in section 5(2) of the Education Act 1996;

"school" means a community, foundation or voluntary school (but not a special school) which is maintained by the LA;

"VA schools" means those schools which are voluntary-aided church schools;

"Academy" means a publicly funded independent school;

"Free School" means a publicly funded school;

"admission authority" in relation to a community and voluntary controlled school means the LA and, in relation to a VA schools and Academies, means the governing body of that school;

"determination year' means the academic year (i.e. the period from 1 August to the following 31 July) immediately preceding the offer year. This is the academic year in which admission authorities determine their admission arrangements;

"admission arrangements" means the overall procedure, practices, criteria and supplementary information to be used in deciding on the allocation of school places and refers to any device or means used to determine whether a school place is to be offered;

"in-year admission" means any application for a place in a school in any year of education that is received after 1 September 2015 except in the case of admission into Reception and Y7 in which case these will be treated as the 'normal' round of admissions up to the end of the Autumn term 2015:

"nearest appropriate school" is defined as the school closest to the home address with places, unless your child is a baptised Catholic then a place would be offered at the nearest Roman Catholic School with places.

# Applying for a school place

- 3. There will be a standard form known as the Common Application Form (CAF) which will be used for the purpose of admitting pupils into the reception class for primary school and the first year of secondary education in the determination year. In the main rounds for applications for primary and secondary places, an on line facility will be set up to enable parents to apply for places on line. A separate form known as the 'In year application for change of school' will be available for any applications made for an "in year transfer" into any year group. There is no on line facility as yet although a form can be downloaded from the Stockton on Tees website.
- 4. The on line application / CAF and 'In year application for change of school' form must be used as a means of expressing one or more preferences for the purposes of section 86 of the School Standards and Framework Act 1998, by parents resident in the LA area who wish to express a preference for their child:
  - (a) to be admitted to a school within the LA area (including VA schools, Academies and Free School).
  - (b) to be admitted to a school located in another LA's area (including VA schools and Academies).
- 5. The on line application / CAF and "In year application for change of school" form will:
  - (a) invite parents to express three preferences by completing the form including, where relevant, any schools outside the LA's area, in rank order of preference;
  - (b) invite parents to give their reasons for each preference.

## The CAF will:

- (c) Specify a closing date (for the determination year) and where it must be returned.
- 6. The LA will make appropriate arrangements to ensure:
  - (a) that the on line application / CAF is available on request from the LA and the 'In year application for change of school' form will be available from the LA and schools; and
  - (b) that a written explanation of the scheme is available from the LA and on their website.
- 7. All preferences expressed on the on line application / CAF are valid applications. The governing body of a VA school can require parents who wish to nominate, or who have nominated their school on the CAF, to provide additional information on a supplementary form only where the additional information is required for the governing body to apply their oversubscription criteria to the application. Where a supplementary form is required, this will be requested after the VA schools have received information from the LA about who has applied for their schools. Information requested on the supplementary form should be returned by the parent to the individual school by the due date specified by the school.
- 8. Where a school receives a supplementary form it will not be regarded as a valid application unless the parent has also completed either the Stockton on Tees on line application / CAF or, if resident in another area which has a CAF, their home area's common application form, and the school is nominated on it. Where supplementary forms are received directly by VA schools the school must inform the LA immediately so it can verify whether a CAF or neighbouring area's CAF has been received from the parent and, if not, contact the parent and ask them to complete one. In these circumstances, the school should also send the LA a copy of the supplementary form if so requested. Under the requirements of the scheme, parents will not be under any obligation to complete an individual school's supplementary form where this is not strictly required for the governing body to apply their oversubscription criteria.
- 9. Some Voluntary Aided schools governing bodies have opted out of the co-ordinated admissions scheme for in year transfers, a list of these schools will be made available for parents before September 2016 on the Stockton website. Parents are still required to complete an application form from the LA and schools need to inform the parents and the LA of the outcome of the request.

# **Processing of CAFs**

- 10. Completed CAFs (on line or paper) should be returned to the LA:
  - (a) for secondary schools by the **31 October 2015**\*. The LA will enter information for all the schools within the Borough onto their system and forward information for applications to VA schools and other LAs at the latest by the **13 November 2015**.
  - (b) primary schools by the **15 January 2016\***. The LA will enter information for all the schools within the Borough onto their system and forward information for applications to VA schools and other LAs at the latest by **1 February 2016**.
  - (c) Online applications the facility to apply for a school place on line will be open during the time for application 7 September to midnight on the 31 October 2015 for secondary and for primary 9 November 2015 to midnight on the 15 January 2016.

\*If the closing date falls on a Saturday or Sunday, any applications received through the post, which includes the post box in the Municipal Buildings, on the Monday morning after that date, will be classed as on time. Any others received after this will be classed as late.

# **Allocation of places**

11. Places will be allocated using the Equal Ranking Scheme\* for Primary and Secondary by all admission authorities within Stockton on Tees.

\*Equal Ranking means that all of the preferences written on the CAF or on line form will be considered as a separate application for each school.

# SECONDARY ADMISSIONS - Determining offers in response to the CAF

- 12. The LA will act as a clearing house for the allocation of places by the relevant admission authorities in response to the CAFs. The LA will only make any decision with respect to the offer or refusal of a place in response to any preference expressed on the CAF where:
  - (a) it is acting in its separate capacity as an admission authority; or
  - (b) an applicant is eligible for a place at more than one school, or
  - (c) an applicant is not eligible for a place at any school that the parent has nominated.
- 13. The LAs system for online applications will become 'live' from the **7 September 2015** to midnight on the **31 October 2015** with the closing date for return of CAFs also the **31 October 2015**
- 14. By the 13 November 2015 the LA will notify the admission authority for each of the schools of every application that has been made for that school. Where parents have requested a place at a school outside of the LA area, the information will be forwarded to the relevant admission authority/authorities.

VA schools and Academies to make arrangements to gather information required from parents and set up admission committees for allocation of places.

15. By 8 January 2016 - VA schools, other LAs and Academies, inform LA of allocation of places for all applications received in the priority order of their admission policy. Any applications which are refused also need to be listed in order of priority.

The LA compares lists and considers all preferences from the parent and if first preference is refused then will look to see where 2<sup>nd</sup> or 3<sup>rd</sup> preferences can be accommodated. The lists will be sent back to the VA schools and Academies for their approval before finalising allocations.

Liaison will take place with VAs, other LAs and Academies until the allocation of places is resolved for each application, as required.

- 16. By the 8 February 2016 the LA will match ranked lists for all schools and:
  - (a) where the child is eligible for a place at only one of the nominated schools, that school will be allocated to the child;
  - (b) where the child is eligible for a place at two or more of the nominated schools, they will be allocated a place at whichever of these is the highest ranked preference;
  - (c) where the child is not eligible for a place at any of the nominated schools, they will be offered a place at the nearest appropriate school with a vacancy or asked to contact School Admissions for an alternative school.
- 17. **On 1 March 2016** the LA will post letters (2<sup>nd</sup> class post) to parents to let them know which school has been allocated to their child. If they have applied on line they will receive an email on the 1 March or the next working day. The letter will also tell them of their statutory right to appeal if they have been refused a place at their preferred school.

Parents will need to request an appeal form and return to Democratic Services, Municipal Buildings, Church Road, Stockton on Tees TS18 1XE within 2 weeks of receipt of the form.

# PRIMARY ADMISSIONS - Determining offers in response to the CAF

- 18. The LA will act as a clearing house for the allocation of places by the relevant admission authorities in response to the CAFs. The LA will only make any decision with respect to the offer or refusal of a place in response to any preference expressed on the CAF where:
  - (a) it is acting in its separate capacity as an admission authority; or
  - (b) an applicant is eligible for a place at more than one school, or
  - (c) an applicant is not eligible for a place at any school that the parents have nominated.
- 19. The LAs system for online applications will become 'live' from the 9 November 2015 to midnight on the 15 January 2016 with the closing date for return of CAFs also the 15 January 2016. Packs for admission to Primary School will be distributed to all parents. Applications are to be made on common application form and all applications returned to LA.
- 20. **By 1 February 2016 –** the LA will notify the admission authority for each of the schools of every application that has been made for that school. Where parents have requested a place at a school outside of the LA area, the information will be forwarded to the relevant authority/authorities.
  - **After 1 February –** All VA schools and Academies make arrangements to gather information required from parents and set up admission committees for allocation of places.
- 21. **WC 7 March 2016** VA schools, Academies and other LAs inform the home LA of allocation of places for all applications received in the priority order of their admission policy. Any applications which are refused also need to be listed in order of priority.

The LA compares lists and considers all preferences from the parent and if first preference is refused, look to see where 2<sup>nd</sup> or 3<sup>rd</sup> preferences can be accommodated. The lists will be sent back to the VA schools and Academies for their approval before finalising allocations.

Liaison will take place with VA, Academies and other LAs schools until the allocation of places is resolved for each application, as required.

- 22. By the 25 March 2016 the LA will match ranked lists for all schools and:
  - (a) where the child is eligible for a place at only one of the nominated schools, that school will be allocated to the child;
  - (b) where the child is eligible for a place at two or more of the nominated schools, they will be allocated a place at whichever of these is the highest ranked preference;
  - (c) where the child is not eligible for a place at any of the nominated schools, they will be offered a place at the nearest appropriate school with a vacancy or asked to contact School Admissions for an alternative school.
- 23. On the 16 April 2016 the LA will post (2<sup>nd</sup> class) out a letter to parents informing them of their allocated school. If they have applied on line they will receive an email on the 16 April. The

letter will tell them which school has been allocated and their statutory right to appeal if they have been refused a place at their preferred school.

Parents will need to request an appeal form and return to Democratic Services, Municipal Buildings, Church Road, Stockton on Tees TS18 1XE within 2 weeks of receipt of the form.

## NO CAF RECEIVED BY THE LA

24. Where no CAF is submitted for primary or secondary school, the child will be offered a place at the nearest appropriate school with a vacancy or will receive a letter from the LA requesting that they make contact to discuss further.

#### LATE APPLICATIONS

25. CAFs received after the closing date will be dealt with after all the other applications have been looked at unless there is a good reason, e.g. if a family moves into the area. If that is the case, the application can be considered along with all of those that came in on time as long as the allocations have not been started.

The LA will continue to co-ordinate applications for admission in September 2015 for any late applications for primary or secondary, received e.g. after the closing date and post offer date up until the start of that school year.

## **WAITING LISTS**

26. The LA will maintain a waiting list for all oversubscribed maintained Stockton on Tees Schools. The waiting list will be open for all Primary and Secondary schools for the duration of the next academic year (September 2016 to July 2017). Places will be allocated, if they become available, in accordance with the LAs published oversubscription criteria.

VA schools, Academies and Free Schools are required to keep a waiting list for at least the Autumn Term of 2016, if places become available at their school, the governing body will allocate places from their own oversubscription criteria and inform the LA. The LA will write to parents informing them of the decision.

27. Where the LA is able to offer a place to a non Stockton-on-Tees child from the Waiting List, we will liaise with the home LA, who will write to the parent to confirm the place.

# Admission Policy for September 2016 for Primary and Secondary Community and Voluntary Controlled (VC) School in Stockton-on –Tees

All governing bodies are required by section 324 of the Education Act 1996 to admit to the school a child with a Statement of Special Educational Needs (SEN) or an Education, Health and Care (EHC) Plan that names the school. **This is not an oversubscription criterion.** This relates only to children who have undergone statutory assessment and for whom a final statement of SEN or an EHC Plan has been issued.

Where there are more applications for a school than there are places available, places will be allocated in order using the oversubscription criteria below:

1 Pupils who are in the care of the local authority, or a child who was previously looked after but immediately after being looked after became subject to an adoption, residence, or special guardianship order.	A "Looked After Child" is a child who is (a) in the care of a Local Authority or (b) being provided with accommodation by a Local Authority in the exercise of their social services functions (see definition in section 22(1) of the Children Act 1989) at the time of making an application to school. The Local Authority may request a copy of the adoption order, residence order or special guardianship order and a letter from the Local Authority that last looked after the child confirming that he or she was looked after immediately prior to the order being made.

3 Pupils who have a brother or sister living at the same address, who are still at the school when the pupil begins.	<ul> <li>We define brother or sister as follows:</li> <li>A brother, sister, stepbrother, stepsister, adopted brother or sister, or children of partners who are living at the same address as a family un In all cases, the parent who receives the Child Benefit for those children must permanently live at that address with the children.</li> <li>We will consider brothers or sisters who live in separate households because the parents are separated and have shared responsibility for the children under conditions covering exceptional circumstances (subject to approval by the Panel mentioned in the explanatory notes for criterion 5). 4 Pupils resident within the admission zone who have returned a Common Application Form by the closing date (31st October 2015 for Secondary applications and 15<sup>th</sup> January 2016 for Primary applications).

When a school is oversubscribed with in-zone applications i.e. there are more applications from children living in the admission zone of the school than there are places available, we will allocate places:

- firstly to children living in the admission zone (Criterion 4) with social or medical reasons for attending the school (Criterion 5);
- then to children living in the admission zone (Criterion 4) according to their distance from the school measured in a straight line ("as the crow flies").

5 Pupils who have social or medical reasons for being admitted to the school which would, should the child not be admitted, cause him or her to be seriously disadvantaged or put their personal safety at risk. In all cases corroboration will be sought from independent sources such as a medical specialist who has had continued involvement over a period of time; a social worker; an attendance officer; or another professional. It should be noted that places would not be allocated on the basis of aptitude or ability.

We set up a panel of professionals from Children, Education & Social Care to look at any applications where there are social or medical reasons for a child to attend a particular school. In all cases parents must provide written information from independent sources to confirm the social or medical condition and to explain why the child has to attend the preferred school as opposed to any other. Please note that submitting this information does not guarantee that your child will be included in this category. The panel will make a decision as to whether your child's needs can only be met in your preferred school or whether they could be met in any Stockton school.

6 Pupils who live closest to a particular school measured in a straight line ("as the crow flies").

The LA uses a Geographic Information System, known as GIS, to identify and measure the distance from the home to the school. The distance is measured electronically from a point of the school (the same point for all applications) to a point of the home (including flats). The GIS undertakes all measures in exactly the same way for every applicant, to ensure consistency and fairness.

The proposed criteria will be available in the LA's published booklet for parents 'Primary and Secondary Admissions 2016 Guidance Booklet.'
