## 1.0 Introduction

A study of the rural villages within Stockton-on-Tees Borough was undertaken in 2008, to underpin and support policy development within the Local Plan. Since this date the Core Strategy has been adopted and National Planning Policy Framework (NPPF) has been introduced.

The reasoned justification to Core Strategy policy CS1 'The Spatial Strategy' identifies that the 'Planning the Future of Rural Villages' study will assist the Council in applying its approach to housing proposals in the rural area'. The elements of the 'The Spatial Strategy' which relate to housing are to be superseded by policy within the Regeneration and Environment Local Plan. Emerging policy within the Regeneration and Environment Local Plan continues to identify this study as the basis for the Council in applying its approach to housing proposals in the rural area.

Previous village studies have included an audit of 'services and facilities' and a 'sustainability study'. The 'sustainability study' sought to score villages in terms of access to services and facilities and resulted in a hierarchy of villages being established. This hierarchy was the basis for a number of policy recommendations which sought to resist housing development in those locations where residents are reliant upon the private car to access services and facilities.

The NPPF introduces the presumption in favour of sustainable development. There are three dimensions to sustainable development: economic, social and environmental. The NPPF identifies that these dimensions give rise to the need for planning system to perform a number of roles:

- an economic role contributing to building a strong, responsive and competitive economy, by ensuring that sufficient land of the right type is available in the right places and at the right time to support growth and innovation; and by identifying and coordinating development requirements, including the provision of infrastructure;
- a social role supporting strong, vibrant and healthy communities, by
  providing the supply of housing required to meet the needs of present and
  future generations; and by creating a high quality built environment, with
  accessible local services that reflect the community's needs and support its
  health, social and cultural well-being; and
- an environmental role contributing to protecting and enhancing our natural, built and historic environment; and, as part of this, helping to improve biodiversity, use natural resources prudently, minimise waste and pollution, and mitigate and adapt to climate change including moving to a low carbon economy.

Within these overarching roles the NPPF identifies a set of core land-use principles that should underpin both plan-making and decision taking. Of pertinence to the rural villages is the following core planning principle which identifies that planning should 'actively manage patterns of growth to make the fullest possible use of public transport, walking and cycling, and focus significant development in locations which are or can be made sustainable'.

From the emphasis of the NPPF it is clear that reducing reliance upon the private car by promoting development in locations where prospective residents will be able to access services and facilities by sustainable means remains an important aspect of sustainable development. It is therefore appropriate to continue an audit of 'services and facilities' and undertake a 'sustainability study' to identify sustainable villages to support policy development within the Regeneration and Environment Local Plan.

## 2.0 Audit of Services and Facilities

The original audit of services and facilities was undertaken in 2007. The audit for each village has been updated to reflect the position at the date of this document and the full audit is attached in Appendix 1.

Information was collected under the following topic areas:

- Dwelling stock within the development boundary was calculated using the Gazetteer address points.
- Population within the development boundary of the settlement is taken from our own estimate, based on dwelling stock. A multiplier of 2.4 people per household has been used to calculate population. It is accepted that this will not be accurate but it gives an estimate of the population.
- Village Services available in each settlement, such as shops, pubs and post offices, were recorded.
- External Links looked at how close villages are to larger centres, and recorded distances by road to services not available in the settlement, such as secondary education, or to higher order centres.
- Public Transport is divided into two sections; public transport provision linking
  the villages to destinations entirely within the district, and also to destinations
  outside the Borough. The time taken to travel by public transport to some
  services and facilities was also recorded.
- Bus services to schools in the urban area are provided in certain locations by the council as a requirement (discussions with the Community Transport Team have established where these are available).
- Quality of Pedestrian and Cycling Links considered the provision of links to other villages, or more urban areas, such as pavements and cycleways.
- Flood Risk Zones have been taken from Environment Agency mapping.
- Additional notes were made where appropriate.

The Council operate a Mobile & Home Library Service; timetables for these services are available on the Council website.

## 2.1 Methodology

Standard data collection forms are contained within Appendix 1 to ensure the same level of information was collected for each village. The information has been collected under the following headings:

- Village Services, including shop or post office, schools and community facilities.
- Distances to other facilities.
- Public Transport Links.
- Quality of Pedestrian and Cycling Links.

The settlements covered by this report are:

- Aislaby
- Carlton
- Cowpen Bewley

- Elton
- Hilton
- Kirklevington
- Long Newton
- Maltby
- Redmarshall
- Stillington
- Thorpe Thewles
- Whitton
- Wolviston

A summary of services available within villages is set out overleaf in Table 1.

Previous studies have included Wynyard. However, as part of the emerging Local Plan the council are seeking to create a sustainable settlement at this location through the promotion of development of the north and south of The A689. Residential development was proposed on both sides of The A689, necessary community facilities (including schools) and employment development to the north of the A689. A key aspect emerging policy is the creation of attractive segregated pedestrian and cycling crossing points over The A689 to provide sustainable movement and increase access services, facilities and employment.

Recently a number of planning permissions have been approved which are broadly in accordance with the emerging plan. Owing to this it is considered appropriate that Wynyard no longer be considered a village and rather an emerging sustainable settlement.

## 2.2 Conclusions of the Services and Facilities Audit

The following broad conclusions were drawn from the study:

- No secondary education provision in rural areas.
- Four villages have primary school provision (Stillington, Wolviston, Kirklevington and Long Newton).
- Of those with a primary school, two have a post office (Stillington and Wolviston) and two have a small range of shops (Stillington, Wolviston).
- The majority of villages have limited services and facilities.
- Residents of Whitton, Thorpe Thewles, Carlton and Redmarshall use certain facilities within Stillington.
- Maltby and Hilton look towards Stokesley for some services and facilities.
- Long Newton looks towards Darlington for some services and facilities.

## 2.3 Bus services

Subsidies to non-commercial bus services across the Borough ended in March 2014. This alongside other changes to services/routes by operators has altered the services to some villages within the Borough. The main services serving the villages are the Leven Valley Coaches Service 84 & A66 and Arriva Service 21a.

Operators can withdraw services provided notice is submitted to the Traffic Commissioners under the 1985 Transport Act; therefore, whilst all bus services were correct at the time of writing they may be subject to change in the future.

The Council have made some funding available to assist those communities where the removal of subsidies has led to the loss of services. Through working with Parish Councils and the third sector, some of this funding has now been used by Long Newton Parish Council to commission a bus service which will facilitate travel from Long Newton and Elton to Stockton Town Centre and other destinations from late 2014. Further schemes may come forward in the future. Funding is intended to support the establishment of Community-led services which are likely to become sustainable and therefore likely to continue without the need for financial support. The services will be reviewed regularly to ensure that funding is being used effectively and that the service is progressing towards becoming sustainable.

## 3.0 Sustainability Study

In considering whether a location is sustainable it is necessary to consider what services and facilities are used by residents and how frequently they are used/accessed. In addition it is also necessary to consider other reasons for travel such as for work. By understanding this it is then possible to determine whether a location is considered a sustainable location for further development.

The previous village studies sought to apply a methodology of scoring for a number of topic areas to understand the ability of residents to access services and facilities by sustainable means. As a result of this a hierarchy was established with those scoring highly being considered appropriate for infill development. Whilst this methodology was useful, the scoring is based on a crude methodology and the Council consider that a more robust assessment of sustainability can be undertaken by considering what makes a sustainable location as expressed in the preceding paragraph.

In this regard it is considered that to be a sustainable location a village must have a:

- Range of facilities within the village capable of meeting at least some of the basic needs of its residents
- Ready access by sustainable means to other services and facilities
- Ready access by sustainable means to sources of employment which are realistically likely to provide employment to residents.

Villages that meet the above criteria are those where residents have the ability to access services, facilities and employment by sustainable means in such a way to minimise reliance upon the use of the private car.

## 3.1 In-village services and facilities

The audit of 'services and facilities' provides detailed information regarding the level of services and facilities within each village with Table 1 providing an overview of this information. This information has been replicated in Table 2 with a view to highlighting the main services and facilities which are used/accessed by village residents. It is noted that certain facilities are likely to command a greater frequency of trips than others.

The only location to contain an employment allocation is Stillington. Whilst other villages contain sources of employment such as shops, public houses, schools, care homes and nurseries they do not provide a significant level of employment for village residents. Therefore, village residents are likely to be employed within Stockton or other surrounding towns within the Tees Valley and the presence of these small scale employment sources is unlikely to significantly reduce the need to travel. Whilst Stillington has an employment allocation and there is likely to be a reduced need to travel for work a significant number of residents continue to be employed within Stockton and other surrounding towns within the Tees Valley.

## 3.2 Access to other services and facilities

#### Pedestrian/Cycle Links

It is noted within the audit of 'services and facilities' that certain villages have pedestrian and/or cycle links to the main conurbation or other villages. Whilst these links provide opportunities to access services and facilities they do not substantially increase the sustainability of any particular settlement as their presence does not markedly reduce the reliance upon the private car; this is by virtue of the distance to these services.

This argument has been tested at appeal in Elton where the inspector, when considering an application for a single dwelling within the village, stated 'Elton is closer to the built up area of Stockton, with its facilities and employment opportunities than other villages noted, but this would not significantly reduce reliance on the car...'. (Appeal Decision APP/H0738/A/08/2089969)

## Shared services

Stillington, Whitton, Redmarshall and Carlton are clustered in close proximity to one another. At appeal it has was argued by an applicant that Redmarshall can be considered as part of a sustainable cluster of settlements to the north of the Borough. However, this argument was not supported by the inspector who noted that whilst Carlton and Stillington have a greater range of facilities than Redmarshall, those facilities were not in his view of such a range and level to contribute significantly to make Redmarshall sustainable. The inspector continued to state that whilst 'there is some employment in Stillington and to a lesser extent Carlton, it is all on a fairly modest scale and unlikely to offer more than a handful of job opportunities to new residents in Redmarshall.' (Appeal Decision APP/H0738/A/08/2064717)

Whilst it is acknowledged that village residents are likely to access services and facilities within nearby villages the Council do not consider there are any specific links between villages which would contribute significantly to making them sustainable in their own right and concur with the inspectors findings for the northern villages that they 'appear to be essentially disparate communities dependant to a greater of lesser extent on Stockton and neighbouring towns for services and jobs'.

#### **Bus Services**

The preceding discussions highlight the extent to which village residents rely upon Stockton and neighbouring towns for services and jobs. In order to access these by sustainable means the provision of a bus service is essential. Table 3 below develops upon information collected in Table 2 and provides information of bus services including their frequency and destinations.

It should also be noted that those villages served by bus services 84 and A66 have access to Stockton Railway Station and Billingham Station respectively.

Elton and Long Newton are served by a new service (88), which operates a limited number of trips on a Wednesday and Friday to a number of destinations. Service times do not allow for commuting during normal office hours.

## 3.3 Composite Sustainability hierarchy

Based on the above consideration of in-village services and facilities, and sustainable transport links it is possible to provide a hierarchy of relative sustainability.

## 4.0 Summary and Conclusions

Both assessments result in a similar hierarchy of relative sustainability, with Stillington being identified as having the greatest access to the greatest level of invillage services and access by sustainable means. Wolviston and Carlton are identified next in the hierarchy of sustainability; importantly these villages score positively against the three criteria identified as being essential for a sustainable village.

Kirklevington and Long Newton have a similar level of in-village services and facilities as Wolviston and Carlton. However, Kirklevington does not have a bus service and Long Newton only has a limited service on a Wednesday and Friday which does not allow for commuting during normal office hours. A regular bus service operating during commutable times and preferable on Saturdays is considered necessary to enable all residents to access services and jobs by sustainable means. It has also been identified that Kirklevington and Long Newton do not have a shop; this has led to a mix score against whether there are a 'range of facilities within the village capable of meeting at least some of the basic needs of its residents'; as it is considered that a village shop is necessary to meet the convenience 'top up' needs of many residents.

Emerging policy within the Regeneration and Environment Local Plan provides a Housing Spatial Strategy (policy SP2) which identifies this study will be used to consider proposals for infill development with villages and development to meet rural affordable housing needs.

From this study it is concluded that the following villages are those which are considered sustainable villages:

- Stillington
- Wolviston
- Carlton

## **AISLABY APPRAISAL**
