

# Safer Stockton Partnership

**SSP 7/15 Minutes of YOT Management Board Meeting 5 May 2015**

**SSP 9/15 Private Rented Sector - Driving Up Standards**

The Partnership was presented with a report that provided information to the Safer Stockton Partnership on an initiative operated by the Councils Private Sector Housing Team (supported by other Council service teams and external partners).

The Private Rented Sector (PRS) had been growing nationally at an unprecedented rate over recent years, a position which was reflected in the Borough. Against this background local authorities across the country sought to work in a proactive manner with PRS landlords one which sought to support good landlords and ensures unscrupulous landlords were targeted in an effective manner.

Following Cabinet approval (November 2014) the Private Sector Housing Team was progressing a '10 Point Plan'; actions detailed within the plan were intended to send a clear message out regarding the Councils intention to promote best practice and drive up standards (both property condition and management) across the PRS.

The partnership felt that they would like to receive regular updates on the scheme.

AGREED that the report be noted.

**SSP 10/15 Revised Channel and Prevent Guidance update**

The Partnership received an update on PREVENT and CHANNEL.

Members were reminded that a report to the Partnership on 10th February outlined the key changes to PREVENT and CHANNEL duties as part of the revised Counter Terrorism and Security Act which came into law on the 12th February 2015.

The report outlined the proposed approach in Stockton which was agreed both

by the partnership and by Stockton Borough Council CMT.

The Cleveland-wide PREVENT Silver group (currently Chaired by Stockton Borough Council) was also in the process of developing a 'rolling' action plan to further address the revised guidance as well as ensure that all four localities and partners were aware of the key issues and were contributing to the wider Prevent agenda.

An initial training and awareness raising session was held with 36 staff from local authorities and partner agencies across the four Tees areas in May. This was an initial introductory session to highlight the key elements of the Home Office WRAP 3 (Workshop to Raise Awareness of Prevent) training. It was envisaged that this would continue to be rolled out to front line staff, elected members and other bodies such as Tees Adult Safeguarding Board in the coming months.

Following approval by the Cleveland PREVENT Silver Group, the action plan would be shared with members of the Partnership for information and possible input. A further discussion on how to raise the awareness of PREVENT could also be conducted at Partnership should members feel that this may be of benefit.

AGREED that the report be noted.

#### **SSP 16/15 Recorded Crime and Disorder**

The Partnership was provided with an overview on crime and ASB levels in the Borough between April 2015 and May 2015.

It was reported that there had been an increase in both publicly reported crime and total crime. Members had a discussion on the figures and the increases and it was felt that the Borough was seeing the outcome of the governments austerity measures. It was also reported that Cleveland Police were being more ridged in their recording of incidents. Members felt these two factors were the main reasons for the increases. It was reported that a brief explanation of the revised Police recording practices would be provided for information at the next meeting of the Partnership.

It was also requested that the Partnership receive an update on the Neighbourhood Watch Scheme.
