7 Crime Survey - summary of key points

The Partnership was presented with a report on the Crime Survey for England and Wales.

The Crime Survey for England and Wales (formerly British Crime Survey) asked people aged 16 and over living in households in England and Wales about their experiences of crime in the last 12 months. These experiences were used to estimate levels of crime in England and Wales. Until recently the survey did not cover crimes against those aged under 16, but since January 2009 it now includes children aged 10 to 15 years.

Respondents to the survey were asked about their attitudes to crime-related issues such as, the police, the criminal justice system, their perceptions of crime and anti-social behaviour. The results of the survey play an important role in informing government policy.

The survey provided a better reflection of the extent of household and personal crime than police recorded statistics because the survey includes crimes that were not reported to, or recorded by, the police. The survey was also a better indicator of long-term trends because it was unaffected by changes in levels of reporting to the police or police recording practices.

It was able to capture all offences experienced by those interviewed, not just those that had been reported to, and recorded by, the police. It covered a broad range of victim-based crimes experienced by the resident household

population. However, there were some serious but relatively low volume offences, such as homicide and sexual offences that were not included in its main estimates.

The survey until very recently excluded fraud and cyber-crime however following the success of recent development work, new questions had been added to the survey from the beginning of October 2015 with initial estimates (based on three months data) beginning to appear in April 2016.

Police recorded crime data were supplied to the Office for National Statistics (ONS) by the Home Office, who were responsible for the collation of recorded crime data supplied by police forces in England and Wales.

13 Alley Gates Maintenance and future use

The Partnership received a presentation on Alley Gates Maintenance and Future Use.

The alleygate programme in Stockton-on-Tees began in 2001 with a pilot scheme in Newtown with 3 alleyways being gated with the installation of 8 alleygates.

Although the alleygate programme, with its dedicated budget came to an end in 2012/13, it was eligible to use the Community Participation Budget to install alleygates, subject to the legislation criteria being met. There was now 327 alleygates installed across the Borough, protecting 4643 properties.

The oldest gates were approaching 14 years old, with the average age of the alleygates being a little under 9 years old. Some of the recently installed gates through the Community Participation Budget had been gates salvaged from housing regeneration areas.

A table within the report highlighted the projected costs per ward for 2015/16, based on the projected cost of the annual scheduled maintenance and the fault repair costs per gate.

A request was made to the Partnership for any help with regard to the maintenance of the alleygates.

An offer was made by David Egglestone (DTV CRC) that there could be the possibility of some un-paid maintenance work from the DTV CRC.

ACTION 13.1 The offer of un-paid work from the DTV CRC be investigated. **DE / MC**

17 Partnership Strategic Assessment

The Partnership was presented with a document that had been produced for the purpose of strategic priority setting to reduce crime and disorder in the borough of Stockton.

The audience for the report was the key decision makers within Safer Stockton Partnership (SSP).

The aim of the assessment was to provide an accurate picture of issues affecting the borough and to aide with setting the strategic priorities for the future.

In previous years the assessment had been prepared on a 12 monthly basis and was used as part of the process to set new actions and priorities in line with the Community Safety Plan 2014-17 (CSP).

In April 2014 this plan was revised and new priorities implemented which had been identified by residents during the Community Safety Audit in the summer of 2013.

The Partnership commended the report and discussed some of the key findings.

ACTION 17.1 The issue of alcohol offending was being looked at and a revised Action Plan would be presented to the Partnership in May 2016. **SH**

ACTION 17.2 The Partnership discussed the restrictions on the report and it was felt that they needed some written clarification from Cleveland Police on why this and other reports contained within the agenda were classed as restricted. However, it was confirmed that the paper on the PSA would have restrictions lifted at a later date and this would be communicated to members at that time. **SH**

ACTION 17.3 With regard to Cybercrime it was felt that it would be appropriate for Steve Rose to raise this issue at the Children Safeguarding Board. **SR**

18 Recorded Crime & Disorder

The Partnership was presented with a report that provided an overview on crime between April 15 and November 15 and anti-social behaviour levels between April 15 and October 15 in

the borough of Stockton.

These details had been taken from Cleveland Police Performance statistics and were restricted due this information not being released to the general public at the time of writing.

The figures for DA were discussed and that DA was a key priority for the Partnership, Cleveland Police and the HMIC.

Stockton-On-Tees was still the safest place in the Tees Valley and although there had been an increase in crime the figures which looked very dramatic they were disproportionate as the crime figures had previously been so low.

AGREED that the report be noted.
