## **7 In Depth Discussion – Violent Crime - Restricted**

Members received reports / presentations on the following areas:-

- Tackling Alcohol Related Crime  
It was report that Middlesbrough CSP had a Local Area Action that had

been very successful and there was a hope that this could be replicated in Stockton. There was also an Alcohol Strategy that worked with the Licensing Department.

- An Overview of Violent Crime  
Members were presented with a Force Analytical Function Briefing Note (TC&P Command)

It was noted that a representative from Cleveland Police would attend future meetings of Education Board Meeting.

AGREED that:-

1. A problem solving approach be adopted to identify repeat locations of North Tees Hospital, Holme House Prison and named schools.
2. Extra patrols take place within Stockton Town Centre outside of the designated NTE hours i.e. Tuesday and Wednesday nights.
3. Case studies be undertaken of the four repeat victims of all violence who have suffered five or more offences to ascertain possible reasons as to why they have become a victim.
4. Repeat suspects be reviewed of all violence that is domestic related who are responsible for five or more offences to ensure all enforcement / preventative measures are in place.

## **8 Recorded Crime and Disorder - Restricted**

Members were presented with a report on recorded crime and anti-social behaviour incidents in Stockton Borough.

A comparison against other similar Community Safety Partnerships had been obtained and related to April 2017 to July 2017. The data provided a more accurate comparison on how the Partnership was performing against other local authorities in the Tees Valley area.

Members were also presented with the Stockton district fire statistics. Members felt it would be beneficial if the Exeter List could be shared with appropriate partners and that this be monitored and brought back to a future meeting.
