Stockton Riverside College continues to be a good college as judged by Ofsted in December 2017 and, in terms of Higher Education, by the Quality Assurance Agency (QAA) in May 2017. This report presents the College's current position as well as future aspirations. **Appendix 1** of this report covers a review of College performance and summarises the College's recent Ofsted inspection as well as a review of the Higher Education provision by the QAA. Detail is then provided regarding the various partnerships that the College has continued to develop particularly with the Council, Schools, Businesses and the Third Sector. There is also specific reference to the planned merger with Redcar & Cleveland College in 2018/19. The report draws attention to the significant work undertaken with Employer engagement, apprenticeships and inclusivity. Also featured in this report is the significant investment made in new technologies.

A Member with a personal interest, as described in **paragraph 18** of the code, may attend the meeting but must not take part in the consideration and voting upon the relevant item of business. However, a member with such an interest may make representations, answer questions or give evidence relating to that business before the business is considered or voted on, provided the public are also allowed to attend the meeting for the same purpose whether under a statutory right or otherwise **(paragraph 19** of the code**)**

Members may participate in any discussion and vote on a matter in which they have an interest, as described in **paragraph18** of the code, where that interest relates to functions of the Council detailed in **paragraph 20** of the code.

Disclosable Pecuniary Interests

It is a criminal offence for a member to participate in any discussion or vote on a matter in which he/she has a disclosable pecuniary interest (and where an appropriate dispensation has not been granted) **paragraph 21** of the code.

Members are required to comply with any procedural rule adopted by the Council which requires a member to leave the meeting room whilst the meeting is discussing a matter in which that member has a disclosable pecuniary interest (paragraph 22 of the code)
