#### STOCKTON-ON-TEES ELECTORAL REVIEW 2020 - WARD BOUNDARY REVIEW-PHASE 2 -WARDING PATTERNS CONSULTATION SUMMARY

To note the response from the Local Government Boundary Commission following submission of our Council Size Commission, and to receive the outcome of the Phase 2 consultation on Warding Patterns which ended on 29<sup>th</sup> October 2020.

# REASONS FOR RECOMMENDATION(S) / DECISION(S)

To comply with instructions from The Local Government Boundary Commission for England.

# RECOMMENDATIONS

Cabinet to recommend to Council that the responses received as part of Phase 2 Warding Patterns consultation be noted and be submitted to The Local Government Boundary Commission for England.

# DETAIL

- Cabinet, at its meeting held on 17<sup>th</sup> September 2020, recommended to Council approval of the proposed Council Size submission, which was subsequently approved by Council (23<sup>rd</sup> September 2020) and forwarded to the Local Government Boundary Commission (LGBC) for comment.
- 2. The Commission have now responded and confirmed that they have approved our future Council Size of 56 Members; a decision which should now be applied when considering the next phase of the consultation, Phase 2 examining warding patterns.
- Phase 2 Consultation on Warding Patterns commenced with all elected members from 24<sup>th</sup> September – 29<sup>th</sup> October 2020.
- 4. The results from this consultation are summarised at **Appendix 1**.
- 5. The deadline for submission of comments as part of this consultation ends on11th January 2021 and comments can be submitted direct to LGBC via their website.
- 6. The Commission's decision on council size will not be formalised until the Final Recommendations are agreed and published at the end of August 2021.

7. The Final Recommendations will describe the complete set of electoral arrangements, including ward names and locations as well as the number of elected members, alongside parish warding arrangements. These recommendations will be implemented at the next election by means of an Order laid before Parliament.
