BRIGHT MINDS BIG FUTURES - 12 MONTH UPDATE

SUMMARY

This report provides Cabinet with a 12-month update on BMBF's Big Objectives document, following Cabinet's approval of the Big Plan. The Big Committee will attend Cabinet on 9 December and present their update.

REASONS FOR PRODUCING THIS REPORT

The BMBF Big Committee welcome the opportunity to present their 12-month review at the Cabinet meeting to highlight areas of good practice, areas of development activity within the Borough and upcoming projects.

DETAIL

1. There have been some excellent achievements in the last 12 months including:
 - Launched the Pot of Gold Funding stream
 - Won a Mayors Civic Award
 - Secured £4,250 to support allotment and Norton Green project
 - Mental Health social media campaign
 - Secret Sound
 - Shining Stars – Primary School Newsletter launched
 - Held British Youth Council Campaigning Workshop
 - Involvement in Stockton on Tees Great Big Green Week
 - Secured £1,000 from Virgin Money for development grant
 - Completed suicide prevention training and sessions on Mental Health and Drugs and Alcohol
 - Working with Primary Schools and local MP's to elect Child MP for Stockton North and Stockton South
 - Held session at Conyers School and Oakwood Primary School
 - Secured £500 from the ARC to launch new Grow Into Real Leaders campaign
 - Shortlisted for Queen's Award for Voluntary Service
2. In addition to the above achievements there has been a significant contribution in making the Borough a great place to grow up through projects and initiatives such as:
 - Scrutiny committee involvement

- Launched Norton Green Eco Project and Stockton on Tees Great Big Green Week
- Relaunch of BMBF Approved
- Supporting Public Health in delivering key Covid-19 messages and design of Sexual Health survey
- Supported the National Market Traders Young Traders Local Heats

3. These achievements will be expanded upon in the presentation.

4. The Big Plan was a large document which outlined in detail the 'wish list' of young people in the Borough 2018/20. Following the election for the Big Committee in August 2020, a full review of the Big Plan was undertaken with feedback from young people identifying the Big Plan was too large (46 pages) and included too much detail. The Big Committee have developed a more succinct version of the Big Plan called "Big Objectives" which is a shortened version highlighting 3 main objectives for each area. A copy is attached at **Appendix 1**. Each elected member of the Big Committee is responsible for developing their own action plan to achieve their Big Objectives. A refresh of the Big Objectives document was due for September 2021, however due to Covid-19 this has been extended to March 2022.

5. Members of the Big Committee will attend Cabinet to provide an update. The full Committee details are as follows:

6. Elections for the Big Committee were due in August 2021, however due to Covid-19 it has been agreed that elections will take place in February 2022. Once members are elected a review of the Big Objectives 2020/21 will be carried out and a report produced on the progress made to date. The newly elected Big Committee will look to produce a new Big Objectives document for 2022/23.

- Young People Services
- Health and Wellbeing
- Business, Regeneration and Transport
- Environment and Green Spaces
- Arts Leisure and Culture
- Special Educational Needs
- Equality and Diversity

Details of the Big Objectives will be presented at the Cabinet meeting.
