### **CYP      Efficiency Improvement and Transformation (EIT) Review of Child 19/09      Placements and Residential Care**

Members were presented with a report on the Fostering Service and the Adoption Service. It was stated that further information would need to be added to the report on the private sector and private fostering, it was also requested that further information on independent fostering be included.

Further information was presented on the different types of fostering arrangements available. Foster Carers receive support from a Social Worker on a monthly basis but were often in contact each week. An out of hours service was also available for any emergencies that foster carers may have.

Stockton works alongside Darlington Borough Council to carry out training to Foster Carers and also liaises with them over placements.

The Service had been previously inspected by Ofsted annually but due to changes in legislation the inspections would now take place every three years. The Service had consistently received 'good' inspection grades.

Discussion was held on advertising campaigns to recruit foster carers. It was suggested that rebranding and sharing the costs of advertising with neighbouring authorities could be considered.

It was stated that the rigorous investigation process to become a foster carer can put people off, there was also a high proportion of people who would apply then withdraw during the process. Shaun McLurg felt that targeted marketing was the most successful way of recruiting.

Discussion was held on appointing independent providers of foster carers to place children and whether the ability to negotiate costs was an option. Members also discussed the possibility of sharing services with other authorities to reduce costs.

Members then went on to discuss the adoption process which on average takes around 8-10 months. It was a lengthy process as the importance of finding the best match for both the child and adopter was paramount. The adoption process could also be a very sensitive process as it often followed a family bereavement.

Discussion was held on research for people tracing their birth families and whether a small fee could be charged to raise income for the service.

The average cost for the adoption process was detailed and whether any costs/processes could be shared with other providers/authorities.

AGREED that the information provided be noted and Members were requested that any further questions be forward to Graham Birtle, Scrutiny Officer, for answers to be provided in writing.
