### **CYP 43/10**      **Minutes for Signing - 9th June, 30th June, 14th July and 1st September, 2010**

### **CYP 45/10**      **Youth Service Review**

Members received information from Sue Barker-Schneider on the Council's use of social networking to communicate with young people. The Council currently makes use of Facebook, Twitter, Flickr and U-Tube to communicate with the public.

The Council's website was very popular with the public and figures for its usage were particularly high during bad weather such as last December when there were over 140k hits. The Council endeavours to keep the website as up to date as possible publicising events, consultations, weather alerts, road closures etc.

Members were informed that a policy was currently being established regarding the use of social networking sites.

The Chairman informed members of a meeting that was being held in Leeds regarding Social Networking by West Yorkshire Council, the Chair had full details should any Members be interested in attending.

Members considered the comments made at the all Member meeting on 21st October 2010. At that meeting Members were provided with each of the draft recommendations and were given the opportunity to break into smaller groups

and comment upon each of the recommendations.

Members made some minor changes to the recommendations to recognise the impact of the Comprehensive Spending Review. It was also felt appropriate to make an additional recommendation to explore using social media as a way to engage with young people.

Members were provided with a matrix of youth services that included factors such as footfall, reach etc. Members requested that the information on the matrix be broken down further in order for them to finalise Recommendation 2. It was suggested that a further meeting be organised on 24th November in order for this information to be received.

CONCLUDED that the information received be noted and that a further meeting be organised for 24th November in order for Members to receive further information with regard to the matrix prior to finalising recommendation 2.
