CYP 26/11 Minutes for Signing - 29th June and 7th September 2011

The minutes of the meetings held on 29th June and 7th September, 2011 were signed by the Chairman as a correct record.

CYP 27/11 Draft Minutes - 5th October 2011

Consideration was given to the draft minutes of the meeting held on 5th October, 2011.

Members requested that a letter of thanks be sent to Mr George Davies who had been a long standing non voting Member of the Committee and had recently retired.

AGREED that the minutes be approved.

CYP 28/11 Task and Finish EIT Review of the Impact of the Introduction of the Early Intervention Grant

Members were provided with a copy of the report that was due to go to Cabinet on 3rd November 2011 that recommended a new approach to Early Years operations which would deliver a more targeted, partnership based service with a commitment to early intervention and support. The new approach would also deliver annual cost savings of approximately £2m.

The Select Committee supported the recommendations for redesigning Early Years Services in the borough, following discussion around the key issues set out below:

- the extent to which the Council had to abide by the DfE guidelines regarding the number of children centres by population;
- the process of setting "reasonable" charges;
- a recognition that targeted families in affluent areas would not be able to

access “closed” sessions in other areas. However, it was noted that there may be some flexibility where capacity existed;

- any partner organisation would need to be subject to robust checks as part of the procurement process;

- there should be a distinction between staff working in the Home Visiting Team (who will transfer into the Children and Young People Operational Service) and social workers.

Members requested a further breakdown of the footfall of registered users at the family centres within the borough. Beccy Brown would email this information to Members of the Committee.

AGREED that the recommendations for redesigning the early years service be supported.
