CSA Annual Update March 2012

Introduction

The Childcare Act (2006) requires Stockton-on-Tees Borough Council, like all other local authorities in England, to ensure a sufficiency of childcare for working parents, parents studying or training, and for disabled children.

The duties in the act require the council to shape and support the development of childcare provision in Stockton-on-Tees (section 6) in order to make it flexible, sustainable and responsive to the needs of the community. This role is described as a 'market management' function, whereby the local authority support the sector to meet the needs of parents, children and young people, along with other stakeholders.

Section 11 of the 2006 Act requires local authorities to prepare an assessment at intervals not exceeding three years but also to keep it under review until it is superseded by a later one. Stockton-on-Tees Borough Council has undertaken an annual review of the assessment as recommended in Section 11 of the 2006 Act.

Sufficient childcare is defined as: -

"Sufficient to meet the requirements of parents in the (Local Authority's) area who require childcare in order to enable them: -

- a) To take up, or remain, in work or
- b) To undertake education or training which could reasonably be expected to assist them to obtain work.

In determining whether provision of childcare is sufficient a local authority:

- a) Must have regard to the needs of parents in their area for:
 - the provision of childcare in respect of which the childcare element of the working tax credit is payable, and;
 - the provision of childcare which suitable for disabled children.
- b) May have regard to any childcare, which they expect to be available outside their area."

Childcare places

Supply of Childcare Places 2011-12

The 2011 CSA reported a total of 4,115 registered places for children aged under 8 years old. Comparing registered provision for children aged 0-7 years in 2012 over 2010 shows that the number of childcare places in Stockton-on-Tees has increased by 228 places.

3 & 4 year old free nursery entitlement

From April 2010 (Sept 2010 for schools) all 3 and 4 year olds where able to access 15 hours free nursery education.

2 year free nursery entitlement

The free nursery education for 2 year olds is specifically linked to economic disadvantage and parents/carers must qualify for national and local criteria before a place is allocated. Stockton-on-Tees Borough Council provides places through 18 providers who have had a good Ofsted inspection outcome, or who had satisfactory and were willing to work with the Local Authority on a focussed quality improvement plan.

Parents can access 10 hours care over 38 weeks. Over the period 2011/12 152 children have accessed the two year old entitlement in Stockton-on-Tees.

From September 2013 all disadvantaged 2 year olds will be able to access 15 hours of free nursery entitlement.

Quality Improvement

The quality of provision in Stockton-on-Tees is generally good, however is below the national average. The following table shows the latest inspection ratings against each type of provider: -

Stockton-on-Tees has now developed its own quality improvement programme, "A Journey to Outstanding", in line with Government guidance. Settings who sign up to the programme will be able to demonstrate their commitment to excellence by going above and beyond the requirements of the Early Years foundation stage (EYFS). Currently 47 settings and 11 childminders have signed up to the programme.

The Way Forward 2012-13

There are a number of actions that need to be taken forward during 2011-12. These

include: -

to have a sufficient range of quality childcare settings, childminders and schools

to meet the requirements of the 1400 places for the 2 year free nursery

entitlement.

· work needs to continue with childcare providers in order to effectively

communicate parent demand and provision of vacancy data to the Families

Information service

ensure childcare is fully inclusive and accessible for all children

ensure childcare in the borough is affordable and sustainable

improve the knowledge and information available to parents

ensure there is a sufficient range of flexible provision within the borough to meet

demand

improve and raise the quality standards in all childcare settings

provide specialist advice and support to all settings in relation to the Statutory

Duty for Local Authorities on delivery of Free Early Years Provision for 2, 3 & 4

year olds
