CYP 31/13 Declarations of Interest

Cllr Norma Stephenson declared a personal interest in item titled Youth Offending Service Annual Performance Report as she was on the Youth Offending Service Panel.

CYP 32/13 Draft Minutes - 28th August 2013 and 18th September 2013

Consideration was given to the minutes of the meeting held on 28th August 2013 and 18th September 2013.

CYP 33/13 Youth Offending Service (YOS) Annual Performance Report 2012/13

The Committee considered the 2012/13 Annual Performance Report of the Youth Offending Service. The main points included were:-

- In 2013/13 the number of young people that came into contact with the youth justice system in Stockton-on-Tees was 392 committing 771 offences. It was noted that this had decreased, as it had nationally.
- Members were provided with a breakdown on the nature of the crimes committed over the year and the demographics.
- Assessment of the young people supervised by Youth Offending Service covered 3 key areas; Likelihood of further offending; safeguarding and risk of harm to the public.
- The Youth offending Service had 3 key performance measurement for 2012/13; Reducing the numbers of first-time entrants; reducing reoffending and reducing the use of custody. The work undertaken and outcomes for each performance measurement was discussed.
- Members were made aware of the national developments in Youth Justice.

AGREED the information be noted.

CYP 34/13 Scrutiny Review of Employment and Education - Strand Two - Provision and Performance

The Committee was provided information on the Stockton-On-Tees Youth

Assembly Annual debate on Getting ready for Work and received presentations from Stockton Sixth Form College, Stockton Riverside College and Education Funding Agency regarding meeting the needs of young people and employers.

The main information from Stockton Youth Assembly Annual Debate note discussed was as follows:-

- Key messages from young people regarding getting ready for work when leaving school.
- The opportunities available in terms of lack of vacancies, travelling to and from work and a lack of experience limiting their opportunities of employment.
- Receiving sufficient and valuable careers advice within schools to help pupils make more informed decisions on their choices when leaving school.
- Having an awareness of the local economy and the job prospects within the area.

- Outcomes for learners.
- Areas for improvements.
- Teaching, learning and assessment process within the college.
- Leadership and management
- Public image and reputation
- Programmes for young people and employers
- Future plans for the college.

- College starting position
- embedding accountability and responsibility
- Transformational partnerships with stakeholders
- Ofsted outcomes for learners and teachers.
- College overall success rates
- Teaching, learning and assessments within college.
- Strategic planning and priorities.

The main information discusses from the presentation from Education Funding Agency:-

- Education Funding Agency role and policies.
- Funding streams
- Interventions when institutions fail.
- Study programme and traineeships.
- Having 14 and 15 year olds in Further Education Colleges.
- Challenges for Stockton.
