CYP 34/19 Inspection of Local Authority Children's Services (ILACS) May 2019

Members received information regarding the Inspection of Local Authority Children's Services (ILACS) May 2019 from the Assistant Director Safeguarding and Looked After Children which included:

- Whilst the outcome was disappointing, no child was deemed unsafe in the Borough.
- A more effective approach to tracking children needs to be in place under the Public Law Outline.

- An Action Plan has been agreed and work commenced promptly; a lot of the Actions have already been completed.
- A further inspection would be carried out in 2020.
