CYP Scrutiny Review of Careers Provision 12/21

The Select Committee considered a progress update including assessments of progress following implementation of the recommendation from the Scrutiny Review of Careers Provision.

Members commented on the positive progress made despite the impact of Covid restrictions and in particular the significant increases in schools meeting the Gatsby Benchmarks.

The Director of Children's Services paid tribute to the work of Ian and his team.

Ian Bartlett and Janine Browne (Stockton and District Advice and Information Service (SDAIS)) gave a presentation covering the following areas:

The key issues highlighted and discussed were as follows:

- Members commented on the outstanding service provided by SDAIS and noted the increasing demand for advice and support and the impact of benefit changes which was anticipated to add significantly more demand on services
- The importance of face-to-face contact and flexibility to offer appointments outside of office hours for working families
- The contract for nationally funded debt advice services was being tendered and this was likely to reduce funding for face-to-face provision.
 Members felt it would be necessary to explore a range of options to bridge the gap
- Recognition that COVID had opened up new channels of communication and new ways of working
- Local Authority funding made up 25 30% of the CABs funding; additional Local Authority funding had also facilitated the Warm Homes; Healthy People scheme
- Fuel poverty was a growing problem particularly for lone parent families although it was positive that Stockton had the highest numbers of switchers in the country

- Work to maximising family income was critical as unclaimed benefits was a huge problem
- The Infinity Partnership had received national recognition for its partnership work by the Institute of Money Advisors

Martin Gray (Director of Children's Services) gave a presentation on a new approach which was being developed to tackle inequality in the Borough. The work complemented the scrutiny review which was highlighted an element of the work. The presentation covered the following:
