### **CYP 4/22**      **Progress Update - Domestic Abuse and its Impact on Children**

The Select Committee considered a progress update in respect of its previous review. The key issues discussed were as follows:

- The positive impact of embedding the Harbour link officers within Children's Services
- Operation Encompass reporting times had improved but it was noted that it could still be two days before incidents were reported to schools depending on the time of day that the incident had occurred
- Collaboration and joint working across the Tees Valley had been a catalyst for a range of positive work
- Robust challenge was being achieved through the Domestic Abuse Steering Group

AGREED that the assessments of progress be confirmed.

The Select Committee considered the draft final report following its scrutiny review. Subject to approval by Cabinet, the Action Plan, setting out how the recommendations would be implemented, would be presented to the July meeting of the Select Committee.
