### **Scrutiny Review of Contextual Safeguarding and Youth Relationships**

The Select Committee received a presentation setting out some background and context for the review and specifically “What makes a Child Vulnerable?”  
The presentation covered:

- The dynamics of adolescence
  - o Risk and motivation for thrills
  - o Short-term thinking and gains
  - o Emotional regulation
  - o Increase desire for autonomy
- Context
  - o Home
  - o School
  - o Peer Group
  - o Neighbourhood
- Push
  - o Family Conflict/ domestic abuse
  - o Being thrown out
  - o Physical, emotional and sexual abuse
  - o Low self esteem
  - o Bullying
  - o Bereavement/ loss
  - o Mental health
  - o Poverty
- Pull
  - o Promises of something they need such as food, housing, money, gifts and drugs (in exchange for a task or actions)
  - o Group acceptance or validation
  - o Adventure or excitement
- Control
  - o Violence or threats of violence
  - o Threats or arrest or criminal conviction
  - o Brain washing

Key issues highlighted and discussed were as follows:

- Children don't recognise that they are being exploited
- The importance of early intervention
- The timeliness of the review
- Perpetrators can be peer on peer as well as adults
- Police and other agencies are actively involved and this will be explored more fully in a further session.
