REPORT OF DIRECTOR OF LAW AND DEMOCRACY

Police and Crime Panel - Member Development

SUMMARY

The report suggests a programme of Learning and Development Activities of Elected Members serving on Police and Crime Panels.

DETAIL

- 1. Members received a report on 10 June outlining the research undertaken on Learning and Development Activities of Elected Members serving on Police and Crime Panels both locally and nationally to identify if members are receiving specific training for their role as Police and Crime Panel Members. The research found that Panel Members in each area had received inductions based on the work of the panel, statutory information and the Police as an organisation.
- 2. Members were requested to identify any specific training needs by completing a Personal Development Plan. Those Plans received have now been considered and no further training needs have been identified.
- 3. In terms of induction training it is suggested that the initial induction pack is circulated to new Panel Members on appointment. If Members have any queries regarding the information in the pack they can contact Democratic Services for assistance.
- 4. The PCC is organising a programme of events to fulfil his commitments in the Police and Crime Plan. To further development their knowledge of the policing and partnership arena, and to better understand the work that the PCC is undertaking, it is suggested that Members may wish to attend these PCC organised events.
