## **Report of the Police and Crime Commissioner to the Chair and Members of the Cleveland Police and Crime Panel**

**Thursday 26 June 2014**

### **Police and Crime Commissioners Police and Crime Plan 2014-17**

#### **1.0 Purpose of Report**

- 1.1 To present the final edition of the revised Police and Crime Plan 2014-17 to Cleveland Police and Crime Panel.
- 1.2 That members note the changes made in the Plan.

#### **2.0 Background**

- 2.1 The Police and Crime Plan is a statutory document. Requirements for the Plan are set out in the Police Reform and Social Responsibility Act 2011 and the Policing Protocol Order 2011. In addition, the Plan must have regard to the Strategic Policing Requirement issued by the Home Secretary.
- 2.2 The PCC has a duty to keep the Plan under review and in particular to review the plan when any changes are made in the Strategic Policing Requirement. The review should also include any report or recommendations made to the Police and Crime Commissioner by the Police and Crime Panel.

#### **3.0 Police and Crime Plan 2014-17**

- 3.1 The Police and Crime Commissioner has undertaken a number of activities in reviewing the Police and Crime Plan, including

- SWOT (Strengths, Weakness, Opportunities and Threats) analysis in July and November 2013
- Report showing 1<sup>st</sup> year in office progress against the plan as reported to the Police and Crime Panel in October 2013.
- Monthly monitoring of progress against objectives.
- PCC and Deputy Chief Constable consultation presentations regarding the budget to each of the four local authorities in November and December 2013.
- Briefing to the Cleveland MPs in December 2013.
- Consultation event with partners in January 2014.

3.2 The 2014-17 Police and Crime Plan style has been refreshed to show what I have done along with planned events and activities for each objective.

The PCC objectives and outcomes expected remain as:

Develop better coordination, communication and partnership between agencies to make the best use of resources	Successful services commissioned
Working for better industrial and community relations	Organisational stability

3.3 The About the Service appendix has been updated to reflect population changes, the national ranking and comparison with most similar forces for Cleveland Police and an updated consultation process.

3.4 The Partnership, Commissioning and Collaboration appendix has been updated to include changes to our partnerships map as well as the new commissioning and collaboration arrangements.

3.5 The Finance and Resources appendix has been rewritten to reflect recent and ongoing downward pressures on finances, staffing and other resources.

3.6 The Governance and Accountability appendix of the Plan has been updated to reflect the revised

- governance framework resulting from the Stage 2 Transfers
- performance framework
- audit, inspection and complaints frameworks.

#### **4.0 Publication schedule**

4.1 The Police and Crime Plan 2014-17 was published on the PCC website on 1 April 2014.

4.2 Copies have been distributed to all main reference libraries, local members of parliament and local authority chief executives. Individual printed copies of the Plan will be prepared if requested.
