## **Decisions made by the Police and Crime Commissioner for** Cleveland for the period January to July 2016

#### 1.0 **Purpose of Report**

1.1 The purpose of this report is to provide the Cleveland Police and Crime Panel (PCP) with an update on decisions made by the Police and Crime Commissioner (PCC) for the period January to July 2016.

#### 2.0 **Background**

- 2.1 The Police and Crime Commissioner makes all decisions unless specifically delegated within the Scheme of Consent/Delegation. All decisions demonstrate that they are soundly based on relevant information and that the decision making process is open and transparent.
