Purpose of Report

The charity provides workshops which are interactive, safe and non-judgemental. The participants are encouraged to reflect on their own internal prejudices in an attempt to reflect on them and in turn to consider an alternative view. The PCC's commissioning intentions set out in the financial year 2019/20 supports the SRtRC project which covers 30 anti-racism education workshops alongside fun, football, fitness sessions in Primary and Secondary Schools and other identified young people focused environments, such as youth clubs, focusing on areas of need as identified by Cleveland Police and community safety partners. | 01/07/19 |

Volunteers provide surveillance cover, 8 hours per day, 7 days a week and report any safety issues to the relevant emergency services including the Coastguard, Police, RNLI and UK Border Agency.

The Station applied for funding to help with their on-going running costs which includes Radar License and Sea Safety Fee.

As the UK's oldest and largest sail training charity, the Tall Ships Youth Trust's (TSYT) mission is to enable young people aged 12-25 years to fulfil their life potential through experiences at sea and by breaking down the barrier they face in society.

TSYT have requested funding from the PCC to enable 10 young people Funding - Tall Ships Youth Trust from Cleveland who are young offenders or at risk of offending to take £3,000 part in a TSYT voyage. The voyages bring together a complete crosssection of young people to work and live in an unique, physically and mentally challenging sea-going residential environment, which allows them to develop independent living skills along with work-based skills and community skills. The young people will live and work together as a small community as sea and will lead all activities on board.

Fighting Chance Billingham Boxing Club has been set up by a team of volunteers. The clubs aims are to deter young people from engaging in anti-social behaviour in and around Billingham. They provide a base for young people to get them off the streets to exercise, learn new skills and

The DAWSA Evaluation is due to be published in July 2019, findings from this report will inform future commissioning priorities from April 2020 onwards. Between now and this time it is suggested that the Domestic Abuse Force Control Room Worker continues to ensure fully informed decision making.

Hartlepool United Community Sports Foundation is the charitable arm of Hartlepool United FC and exists both to promote the club in the community and to deliver positive activities to people of all ages and backgrounds.

The Hartlepool Kicks programme involves diversionary sports provision run in targeted areas of Hartlepool. The community based evening sessions will use a combination of sport and other activities and run as informal turn up and play sessions, in targeted areas as directed by Cleveland Police, with the aim of engaging young people not already taking part in more formal exercise or organisation sport.
