Provisions of school meals to all 60 Primary Schools, two secondary schools and three special needs schools, including breakfast clubs.

Site Visits – Primary, Secondary, Breakfast Club provision, other schools (not catered for through SBC)

Possible questionnaire – To parents/children to complement any existing feedback, including feedback from parents/children opting out of school meals (if necessary).

Parent consultation via in school parents evenings

Pupil consultation via pupil Focus Groups already in place.

Trade Unions and catering employees - consultation throughout the process.

### 5. How will key partners and/or the public be involved and at what stages?

PCT – evidence to Committee – links to Obesity Strategy.

Consultation with Head Teachers and Governing Bodies.

Healthy Schools Team – evidence to Committee.

Stockton Borough Council Procurement – engage with SBC Corporate Procurement during baseline and options stage. The section continually tests the market looking for best value food and supplies needed to deliver the service. During the options stage, depending on the outcomes, if the service delivery is altered, this will have a significant impact on current contracts in place.

School Foods Trust - the School Food Trust is charged with helping all stakeholders to ensure that young people eat better food at school, and has set objectives to achieve this agenda.

The School Food Trust will be used throughout the process to access information from nationwide Local Authorities, for benchmarking data.

Trade Unions consultation throughout the process.

Catering employees - the section has a workforce group, with members from across all front line staff. This group is the main link to report to all other front line operational employees.
