## **1092 Public Question Time**

The Director of Law and Democracy informed the Worshipful the Mayor that no public questions had been received.

## **1093 Members Question Time**

The following question was submitted by Councillor Walmsley: -

'With a report just coming out highlighting pensioner poverty and that the gap between rich and poor has grown alarmingly under the Labour Government and that inflation busting rises in council tax, stealth taxes and power bills is adding to financial hardship, can we now assume that it is local policy to exclude those living in dire straights from any benefits simply because statistically they live in affluent wards – as supported by The Labour Group in a registered vote at Special Council on 1st March 2006?'

The Leader of the Council responded with the following:

'I don't know of any report about to be released on pensioner poverty and so I and my colleagues await it with interest. There is no denying that our own Council precept set at 4.5% is above inflation, the circumstances that led to this level of Council Tax were explained in the report I gave to the Special Council Meeting held on Wednesday 1<sup>st</sup> March. There were no amendments tabled to the revenue budget and it was given All Member support.

Stealth taxes, taxation by stealth - I don't understand this part of the question in the context of poverty, dire straits and financial hardship. The Government's taxation policies are designed to help those who suffered disproportionately from the ravages of poverty.

The basic state pension in April 2006 will be £82.05 for singles and £131.20 for couples, from the same date the poorest of pensioners will be guaranteed £109.45 for singles and £167.05 for couples through the new Pension Credit Scheme.

- To date, the Labour Government has lifted over half a million children out of relative poverty and over two million out of absolute poverty.

- Compared to 1997, families with children are on average £1,350 a year better off in real terms as a result of Labour's tax and benefit reforms; the poorest households with children are £3,000 a year better off.
- New mothers have gained 26 weeks paid maternity leave, fathers 2 weeks.
- Six million families are benefiting from the new tax credits – the Child Tax Credit and the Working Tax Credit boosting the incomes of 2.3 million families.
- Locally there is Warm Zone, Decent Standards, Sure Start
- 1.6 million people are better off thanks to the national minimum wage.
- Winter fuel payments of £200

I could go on and on and on. The recent hike in gas/electric/water bill is an absolute disgrace and will serve only to further line the pockets of greedy executives and their City of London friends, billions of pounds siphoned off into the pockets of fat cat spivs. There is an answer of course, bring back what was stolen from us by the Tories back into public ownership, without compensation.

The Liberal Democrat amendment to which your question refers had nothing at all to do with hardship, exclusion on dire straits, it was not about raising living standards of poor people, it was an attempt to hijack £200K of capital for spending on work outside of those areas in receipt of NRF funding, areas where it is recognised by all of us that is still real need. The amendment was defeated. I would like to thank those non-Labour Councillors who voted with the Labour Group, yourself included Councillor Walmsley for helping to defeat it'.

**1094 Response to the Consultation Document on New Primary Care Trust Arrangements in Co Durham and the Tees Valley**

Members considered a report which brought for approval the response to the Consultation Document on New Primary Care Trust Arrangements in Co Durham and the Tees Valley which had been considered by meetings of the Health Select Committee on 13<sup>th</sup> and 22<sup>nd</sup> February 2006 (Minute numbers 1035-1037 and 1042-1043 refer).

A response to the consultation was required by 22<sup>nd</sup> March 2006 and the Health Select Committee had reviewed the evidence supporting the two options given which were as follows: -

Option 1

- one new PCT for County Durham and Darlington
- one new PCT for Teesside

Option 2 –

- one new County Durham PCT (merging existing ones)
- five PCTs covering Darlington, Harlepool, Stockton on Tees, Middlesbrough and Redcar & Cleveland based on the boundaries of the Unitary Local Authorities

The Health Select Committee concluded that Option 2 provided a Primary Care Trust fit for purpose for the following principal reasons: -

- it retained the essential coterminous model
- it supported the effective partnership arrangements across Stockton on Tees
- it allowed the development of shared health and well being priorities

- there was no real evidence to support many of the assertions within the document that supported Option 1
- the savings could be found in a number of ways and, in any event, North Tees PCT should not be expected to find the share allocated.

RESOLVED that Option 2 within the Consultation Document which retains a coterminous Primary Care Trust with Stockton on Tees Borough Council be supported.

**1112 Supporting Fairtrade**

The following motion under the Council Procedure Rule 12.1 was moved by Councillor Gibson and seconded by Councillor Mrs Rigg:-

'Stockton Borough Council welcomes the Fairtrade campaign supported by national organisations such as Oxfam and Christian Aid and locally by the Youth Assembly and the Joint Trade Union Council and recognises the contribution that Fairtrade can make to the long term alleviation of world poverty.

The Council as an important consumer and opinion leader therefore resolves:

- To promote awareness of Fairtrade issues and make publicity and educational information available to local people concerning the impact of unfair trade and the opportunities that Fairtrade provides to promote sustainable development.
- To encourage the use of Fairtrade products when catering for Council meetings and functions.
- To promote Fairtrade amongst local businesses, commercial and other organisations.
- To allocate the responsibility for meeting the criteria to become a Fairtrade Borough to the Fairtrade steering group.'

The motion was carried.

**1113 Suspension of Council Procedure Rules**

In accordance with Council Rule 22.1, it was moved by Councillor Gibson, seconded by Councillor Coleman and RESOLVED that Council Rules of Procedures be

suspended for the remainder of the meeting, to allow an urgent motion to be considered.

**1114 Review of Police Structures**

The following motion under the suspension of Council Procedure Rules was moved by Councillor Coombs and seconded by Councillor Kirton:

'Stockton-on-Tees Borough Council has grave concerns about the current review of police structures in that the Tees Valley City Region proposals, as supported by this Council, other local authorities, MPs and local communities has been rejected by the Home Secretary, who appears to be moving towards a regional force merging Cleveland, Durham and Northumbria.

We are concerned at apparent proposals to base the regional force in Northumbria, some 60 miles away and at the risk posed to the jobs of over 800 support staff who live and work in the Tees Valley area.

We note that in opinion polls and surveys, around 80% of residents have consistently rejected a regional force, and this has been backed up by over 70 local consultation meetings held by the Police Authority.

We have concerns that £125 million has been committed nationally towards reorganisations costs, but that costs have been estimated by the Association of Chief Police Officers as £836 million.

We note that a new Police Authority for the whole region is being proposed which will have only 12 Council members for the regions 23 police Council Tax precepting authorities. There are also concerns that magistrate expertise, and that of independent members has been reduced to a regional total of 11.

We have serious concerns that, for new structures, the Home Secretary now has reserve powers to appoint both Chairs and members of police authorities and Chief Constables.

We note recent progress made in Cleveland in tackling serious and organised crime, and in long-standing highly recognised emergency planning arrangements and we note the recent comments of the Police Authority Chief executive that he could not recommend a regional structure, as currently proposed, as meeting the authority's responsibility to secure efficient and effective policing in Cleveland.

The Council resolves to support the position of the Police Authority in opposing the regional structure as proposed.
