1047 Progress Report on Implementation of Planning Review

Members were presented with a Progress Report on the implementation of the Planning Services Review. The Head of Planning Services was in attendance at the meeting and detailed the Planning Performance Plan 2006 to 2009 and the Progress Report as at end of December 2006.

The Head of Planning Services reported the Best Value Performance Indicators (BVPI) for the determination of planning applications. The BVPI's showed a good improvement and as a result of the improvement, Planning Services would not be a Standards Authority for 2007/08.

The Head of Planning Services reported that although the recruitment and retention of staff within the Service had improved, the Service was having difficulty appointing an Area Team Leader.

The Head of Planning Services then went on to detail the areas of pressure within the Planning Performance Improvement Plan. Members were then given the opportunity to ask any questions of the Head of Planning Services.

Members were very impressed with the progress that had been made to date and thanked the Head of Planning Services for her attendance at the meeting.
