1036 The Development of Choice Based Lettings

Members were presented with a report produced by Tristar Homes which

highlighted 3 different options available for implementing a Choice Based Lettings scheme in Stockton Borough.

The report also detailed:-

- 1. The shape of service delivery
- 2. Use of single access point to services
- 3. Existing staff
- 4. The use of existing offices
- 5. Options of cost delivery
- 6. Proposed consultation
- 7. I.T system
- 8. Project Plan

Members discussed the advantages and disadvantages of the 3 Options that had been presented to them.

Members felt that the preferred Option would be Option 3 with the inclusion of a sub regional approach and a One Stop Shop. Members also felt that all the relevant financial work should be carried out.

Option 3 would be a sub regional approach as per the ongoing project. It would give a common over-arching policy framework with partners having the further option to adjust according to their local areas. Erimus Housing Policy had already been presented and in the main adopted.

Members then agreed that the Scrutiny Officer prepare a draft report on the Development of Choice Based Lettings. The report would then be considered at the next meeting of the Committee due to be held on 2nd March 2007.

CONCLUDED that:-

- 1. Option 3 for implementing a Choice Based Lettings scheme in Stockton Borough as detailed above be the preferred option.
- 2. A draft report on the Development of Choice Based Lettings be prepared and submitted to the next meeting of the Committee.
