## S Introduction

#### 61/07

The Chairman explained that the Committee had been called to consider the Final Report of an Investigation under Section 60(2) of the Local Government Act 2000 by the Council's Chief Internal Auditor into an allegation concerning a Member of Thornaby Town Council.

## S Declarations of Interest

62/07

Cllr Walmsley declared a personal/prejudicial interest in the matter to be discussed because of a perception of bias affecting the person who was the subject of the allegation.

Mr Bowman declared a personal, non prejudicial interest in the matter as he had previously served on a Parish Council and School Governing body at the same time as the Member who was the subject of the allegation.

# S Exclusion of the Press and Public

RESOLVED that under Section 100A (4) of the Local Government Act 1972 the public be excluded from the meeting for the following items of business on the grounds that they involve the likely disclosure of exempt information as defined in Paragraph 10 of Part 1 of Schedule 12A of the Act.

# S Final Report - Reference under Section 60(2) of the Local Government Act 2000 to the Monitoring Officer, Stockton on Tees Borough Council -Standards Board Reference Number SBE 16748.06

The Investigating Officer presented his report to the Committee and provided Members with details of the complaint.

The Committee was referred to relevant parts of the Code of Conduct which he considered the allegations of misconduct related to: -

•Paragraph 2 (b) and (c) of the Code of Conduct stated that:

A member must treat others with respect and not do anything which compromises, or which is likely to compromise, the impartiality of those who work for, or on behalf of, the authority.

• Paragraph 4 of the Code of Conduct stated that:

A member must not in his official capacity, or any other circumstance, conduct himself in a manner which could reasonably be regarded as bringing his office or authority into disrepute.

The Committee discussed and fully considered the report and its findings and asked questions of the Investigating Officer and Deputy Monitoring Officer.

# S The Standards Committee's decision

67/07

The Committee accepted the findings contained in the report and provided reasons for its decision.

RESOLVED that the findings in the report, that there had been no breach of Paragraph 2 (b) and (c) or para 4 of the Code of Conduct, be accepted.
