CYP 32/07

Review of School Organisation Plan

Members were provided with a report on the School Organisation Plan 2007-2012. The School Organisation Plan provided information about the schools maintained by Stockton-on-Tees Borough Council. It set out the number of places available in schools in each part of the borough, the number of pupils in them, and forecasts for pupil numbers for the next five years. It described changes that had been made over the past year, and it suggested where other changes may be necessary in the future. The Plan also included the Council's policies on school organisation, and new procedures introduced by government for making changes such as opening, closing or enlarging schools.

John Hegarty, Planning and Policy Development Officer, Children and Young People and Steve Turner, Joint Strategy Unit (JSU), were in attendance to

provide information to Members.

Figures were shown indicating the total capacity of both primary and secondary schools in January 2006 and 2007. Pupil numbers were based on projections for 2008 to 2012 as supplied by the JSU.

Primary School pupil numbers had been in decline for several years, but an increase in births during the last three years points to a likely increase in primary numbers by 2010. The decline in primary school pupil numbers over the past seven years was beginning to affect secondary schools. During the first 5 years of this Plan, pupil numbers in Secondary Schools were forecast to fall below 11,000. The lowest point would be in 2016 at 10,409, in the long term the figures were expected to return to around 11,000.

Information was also provided on Post 16 places and further statistics for Primary and Secondary Schools broken down into areas such as Billingham including The Clarendons, Wolviston and Wynyard; Stockton North; Stockton Central; Eaglescliffe, Long Newton, Yarm and Kirklevington; Thornaby and Ingleby Barwick. Information was then also provided on individual Schools indicating pupils on rolls as at the census in January 2007, indicating any surplus or overcrowding at each school.

Detail on action taken since the publication and during the life of the plan was provided.
