LJC Agency, Casual, Sub-Contract Workers within Stockton Borough Council 24/07

The Care for Your Area Service Manager was in attendance at the meeting and presented information relating to the numbers of agency workers in the cleansing/refuse, highways and horticultural areas and also information relating to the impact of mainstreaming agency staff in his service area.

It was advised that there were plans to recruit permanent staff in April 2008 in the Horticultural Section due to retirements.

The Panel ackowledged that it would not be possible to make all agency workers permanent members of staff but agreed that they would like to see a reduction in the numbers of agency workers across the Council.

The Panel agreed that it would be beneficial to see the statistics for agency workers again once the recruitment process in the Horticultural Section had been completed. It was agreed that the statistics would be presented to the next meeting of the Panel.

LJC Single Equality Scheme 3rd Edition

- the higher percentage than the national average of permanently sick and disabled people and people with a long term limiting illness in the Stockton Borough
