## **HCS      Declarations of Interest**

**34/08**

Consideration was given to the minutes of the meeting held on 16th October 2008.

## **HCS      Parish Church Issues**

**37/08**

Members asked questions on issues arising from the previous meeting, in particular the issue of public drinking in Stockton Parish Church Gardens, and cycling on pavements. Members were informed that the Parish Gardens were private land, and that church representatives had so far been unwilling to co-operate regarding the implementation of a no-drinking zone, but that the police would continue to work with the church to examine the problem. In terms of the enforcement of the wider Stockton town centre no-drinking zone, Members were informed that the arrest figures in relation to this may not be significant as the actual offence was that of 'failing to desist from drinking in public when asked to do so by a constable', and most people co-operated with such requests.

In terms of the wider issue of the presence of nuisance drinkers and those sleeping out in the town centre area, the Committee requested that Chief Inspector Allen be in contact with the Council's Housing Options Manager in order to see how many complaints have been made in relation to this, what has been done to remedy the situation, and what can be done in the future.

Regarding the issue of cycling on pavements, members were informed that the police had recently been more pro-active in relation to the enforcement of this.

Members were also informed that as the Safer Stockton Partnership had received two petitions on the issue, a request for extra enforcement powers had been made to the Home Office, and any response received would be reported back to the Committee.

RESOLVED that the information be noted and updates on the issues be reported back as appropriate.

38/08      Review of Neighbourhood Police/Neighbourhood Watch/Outward facing aspects of CCTV**

Consideration was given to the draft scope and project plan for the review of Neighbourhood Police/Neighbourhood Watch/Outward facing aspects of CCTV. Members discussed the scope and project plan, and were informed that it would be helpful if Members provided details of specific pieces of information that they would need from the police, prior to the meetings. In addition to the draft scope, it was also suggested that it may be appropriate to hold focus groups to undertake further research amongst residents, based on the detailed analysis of the 2008 MORI survey when that became available.

The Committee also requested that further relevant evidence should be gathered from the following:-

- All Council Members
- Residents groups via SRCGA
- Neighbourhood Watch Members

The Head of Community Protection informed the Committee that the basic infrastructure for CCTV was getting old and new equipment was needed, and that bids for funding had already been prepared, as part of the financial planning process.

RESOLVED that the requested additions/changes to the draft scope and project plan be added and it be agreed.
