SLF Scrutiny Work Programme - Selection of In Depth Scrutiny Reviews 4/09

The Forum considered a report relating to the Scrutiny Work Programme for 2010/2011.

Members noted that the Scrutiny Work Programme for 2009/2010 had mainly focused on the Council's Efficiency, Improvement and Transformation(EIT)programme. Most reviews had or were nearing completion with the exception of the Fair Access to Care Services Review and the Youth Services Review. Both of these reviews would need to be factored into the Scrutiny Work Programme for 2010/2011.

Topics for 2010/2011 had been sought from Members, Officers and public bodies. Members of the public were able to suggest topics at any time of the year. Each suggestion received had been assessed using the PICK system which scored and helped prioritise topics based on public interest, impact, efficiency and performance and context. A schedule detailing all the suggestions received together with their PICK score was provided to the Forum.

The Forum agreed that Mental Health Services should be referred to the Tees Valley Joint Health Scrutiny Committee. It was noted that the focus of such a review would be the commissioning of services across the Tees Valley.

The Forum was informed that, in addition to the in depth review work, Select Committees would continue to receive the usual action plans and progress reports in respect of the reviews which had concluded. An annual overview meeting would also be held towards the end of the year.

Regeneration and Transport Select Committee had also requested involvement with the review of Winter Emergency Arrangements. The request was being discussed at Executive Scrutiny Committee on 16 February 2010. As an officer review had already commenced, it was likely that a report would be presented to Regeneration and Transport Select Committee during the summer for consideration and challenge prior to consideration by Cabinet.

Health Select Committee would continue to be responsible for receiving statutory and non statutory health consultations and briefings.
