C Mayor's Civic Awards Scheme 3/14

The Worshipful the Mayor recognised the achievements of individuals that had been successfully nominated for a Mayor's Civic Award for people, organisations and businesses who had made a real difference to the community.

The following winners were presented with the Mayor's Civic Award:-

The Young Persons Award - Grace Franklin was the daughter of a former serving officer in the regular army and on her father's tour of duty in Afghanistan, came up with the idea to tell each other jokes at the end of their Skype conversations to cheer each other up and help with the pain of being separated.

On her father's return, and at the age of just seven years old, Grace wrote a children's joke book called "Little Book of Jokes", to raise money for the Royal British Legion. The book was published in time for the 2013 Poppy Appeal and raised over £700.

Grace was in attendance at the meeting to collect the award.

The Services to the Community Award - Individuals

There were three winners for the award.

The first was Kubra Aziz, a volunteer from the Children's Urdu Project and founding Member of Stockton BME Network, who had been teaching children and adults in the community for 35 years as well being involved in a wide range of other volunteering activities.

The second and third winners were Kathleen Morgan and Ronald Nicholas, who had been volunteering at the Council's Mental Health Day Service for more than 25 years. They had supported hundreds of people, taking them out into the community for various activities and day trips, as well as simply sitting with them and listening to them.

The Services to the Community Award - Organisations

The Community Award for organisations was awarded to SNAPS.

SNAPS (Special Needs Activities with Parent Support) started life as a community group in 1999 and became a registered charity in 2012.

All the staff at SNAPS were volunteers who organised activities for families that had children or young people who had a disability or special or additional needs.

As the children and young peoples' parents or carers accompany them, it enabled everyone to share quality time together.

The group also provided both practical and emotional support for parents and carers, and had set up SNAPS Plus to organise activities for Adults.

Ruth Benson, the founder of SNAPS was in attendance at the meeting to collect the award on behalf of the group.

The Green Award

The Green Award went to David Kitchen who, in his role of Chairman of Teesside Environmental Trust, had worked tirelessly for over a decade to develop Saltholme Nature Reserve.

He had done this by forging partnerships with local industry, the RSPB, local authorities and others as well as raising millions of pounds of funds. In 2014 Saltholme celebrated its fifth birthday and was established as one of Stockton's biggest visitor attractions.

Carer / Foster Carer Award

The Carer / Foster Award went to a couple who had been foster carers since 2002 and in this time had cared for many children, including children with special needs, and given them a positive family life whilst working with the child's birth family.

They had demonstrated what excellent and committed carers they were, putting the needs of the children first and ensuring the best outcomes for them.

Stockton Medal

The Worshipful the Mayor had the honour of awarding a Stockton Medal on behalf of the Council to Joe Maloney, the Director of Billingham International Folklore Festival, or BIFF for short.

In 2014 BIFF would celebrate its 50th Anniversary and, as Director, Joe had responsibility of providing leadership for the festival.

His dedication and commitment to BIFF showed in its success, attracting thousands of visitors from outside the Borough, and bringing the best of folklore, dance and song from across the world, both of which impacted positively of the local economy.

Joe's hard work had enhanced BIFF's profile not only regionally but on a national and international level too.

Unfortunately Joe was unable to be at the meeting, but he would receive his medal at a future Council meeting.

Business Award

The Business Award went to Mike Mathews the MD of NIFCO, who had taken a loss - making business based in Stockton and turned it round into a highly successful, profitable, UK division of a Japanese owned company, manufacturing automotive parts and employing around 450 local people.

NIFCO had committed to expanding their business which would bring a further 170 jobs to the borough.

As well as turning the company around, he was a passionate advocate of Stockton as a place to do business, along with the strengths of the North East as a whole.

He was committed to helping young people both through employing apprentices

and visiting schools to enthuse and excite young people about future opportunities for careers in manufacturing.
