#### C Armed Forces Week

#### 80/16

It gave the Worshipful the Mayor great pleasure to welcome representatives from the Freedom Regiments: The Rifles, The Yorkshire Regiment and 1st Close Support Battalion REME.

The region had a proud military heritage, which included supporting veterans, cadets and serving military personnel, and the Council continued that support through its commitment to the Armed Forces Covenant.

Since 2011 the Mayor of the Borough had organised events and activities during Armed Forces Week to honour past and present members of the armed forces. It also provided opportunities for residents of the borough to come and meet with members of the armed forces, civilian support services and cadets.

As part of the Armed Forces Week activities, the Council raised much needed funds for the Freedom Regiments through the 'Mayor's Charity Duck Race'. The total raised from this year's duck race was £1700.31, giving a total £566.77 to each of the regiments.

#### C Presentation of Ministry of Defence's ' Silver Award' 'Employer 81/16 Recognition Scheme

The Ministry of Defence had introduced an Employer Recognition Scheme to recognise and thank employers for their commitment and contribution to supporting Armed Forces personnel and their families.

The Council was awarded the Silver Award and the Worshipful the Mayor presented the Council's Armed Forces Champion, Councillor Stephen Parry with the Silver Award.

## C Welfare Reform Update

83/16

Consideration was given to a report that provided an update on the monitoring of outcomes and impacts of welfare reform and a summary of actions undertaken by the Council to mitigate against circumstances arising from the implementation of these changes.

The monitoring framework was set out under the following issues:

- Advice and Information Services;
- Discretionary Housing Payments;
- Social Fund/Crisis Payments;
- Housing;
- Local Council Tax Support Scheme;
- Employment; and
- General/cross cutting

The reduced Benefit Cap was introduced from 7 November 2016, lowering the maximum amount of benefits payable to claimants outside London by £6,000 to £20,000 (£384.62 per week) for couples and single parents and by £4,800 to £13,400 (£257.69 a week) for single people. The benefits included in calculating the reduced Benefit Cap were detailed within the report.

In Stockton, those affected by the Benefit Cap would have their Housing Benefit payments reduced to bring them to the weekly cap levels.

This much reduced level of Benefit Cap led to 384 couples and single parents being identified as likely to be adversely affected. No single claimants were identified as likely to be adversely affected by the new level of Benefit Cap.

The Welfare Rights Unit had worked in partnership with Stockton Families First, other Council departments and landlords and had managed to contact most of these families, prioritising contact with those at risk of the greatest level of financial reduction.

Details were provided on the outcomes of 206 families contacted to date. Further attempts would be made to engage with the 55 families that had decided not to engage with the Unit.

The Local Government Finance Act imposed a duty upon local councils from 2013-14 to adopt a Local Council Tax Support Scheme (LCTSS), to replace Council Tax Benefit. Members considered a number of options for Stockton's LCTSS and, following public consultation, agreed on the "shared reduction" option with all working age claimants paying a minimum contribution of 20% of the Council Tax charge.

There had been an independent review undertaken of the operation of LCTSS throughout England and Wales, but as yet no formal response from the

government. On that basis, Cabinet were asked to recommend to Council that the existing LCTSS was retained for the financial year 2017-18. Local Council Tax Support Schemes were not fully funded so there could be some impact on the medium term financial plan and reports would be provided as part of the financial report to Cabinet. Any future scheme review would require full consultation with the public.

SBC commissioned a contract for the provision of borough wide advice and information services. The aim of the service was to provide residents with access to a high quality advice and information service which met local needs from simple diagnosis and information through to legal advice, assistance and advocacy and representation at court proceedings. The current contract was awarded to Stockton Advice and Information Services (SDAIS) for two years and expired in March 2017.

Cabinet had considered the matter at their meeting held on 10th November 2016 and a copy of the relevant minute extract was attached to the report.

RESOLVED that the current Local Council Tax Support Scheme be retained for the financial year 2017-18 (see paragraphs 17 to 18 within the report).

#### C Community Governance Review – Grindon Parish

#### 84/16

Consideration was given to a report on the Community Governance Review - Grindon Parish.

Following receipt of a community governance petition which called for the splitting of Grindon into two separate parishes, the report invited consideration of the proposed approach to a community governance review in response to the petition.

A community governance review enabled a principal council to review and put in place new arrangements, making changes to current community governance systems and structures, for example by creating, merging, abolishing or changing parish or town councils in the review area.

The Government had emphasized that the aim of a review should be to bring about improved community engagement, more cohesive communities, better local democracy, and result in more effective and convenient delivery of services.

All principal councils had a legal duty to carry out a community governance review if they received a valid petition. For a community governance petition to be valid in an area of less than 2500 electors, as was the case with Grindon (electors), it must be signed by 187 local government electors, define the area to which the review relates and specify one or more recommendations. The petition called for the splitting of Grindon into two separate parishes along the boundaries of the parish wards of Grindon East and Grindon West.

The petition stated:

"Thorpe Thewles village is part of Grindon Parish Council. The Parish Council works for you and your community influencing planning, fly tipping, environmental issues and local matters. It is also a link to Stockton Borough Council Departments. From the maps attached you can see Grindon Parish Council is in two areas, Grindon East and is mainly Wynyard Park and Grindon West which consists of Thorpe Thewles and The Elms near Junction Road. Over the years the demands and needs of these communities in Grindon West and Grindon East have become more and more diverse due to the number of houses in each area. There are approximately 800 houses in Wynyard and another 400 planned making a total of 1200 whilst in Grindon West there are approximately 200 homes. There is a strong feeling among some residents that Grindon Parish Council should be split into separate areas and manage their own affairs."

Under the Local Government and Public Involvement in Health Act 2007 a principal council had the power to undertake a community governance review, and must set terms of reference that allowed for the petition to be considered. The petition received contained in excess of 187 valid signatures and it was therefore valid.

The DCLG had produced guidance for Principal Councils on undertaking community governance reviews and it had been duly considered in the proposed approach. The guidance highlighted the legislative requirements that a review must have regard to, namely that it:-

- reflected the identified and interests of the community in the area under review, and
- was effective and convenient

Influencing factors that should also be considered were:-

- the impact of community governance arrangements on community cohesion, and
- the size, population and boundaries of a local community or parish

The proposed approach to undertaking a community governance review would commence with Council approving a terms of reference for the review, this must clearly identify the matter/s on which the review was to focus and would therefore include the aims of the review, reference to the legislation that guided it, how the Council proposed to consult, and a timetable that recognised that the review must conclude within 12 months from receipt of a valid petition (received 2016). Terms of reference were attached to the report.

The key stages of the review were as follows:-

Consultation with all Local Government Electors in the area 9 January 2017 – 28 February 2017 Consideration of the wider forms of Community Governance in the area 9 January 2017 – 28 February 2017 Initial findings considered and draft proposals presented for consideration by SMT 13 March 2017 Cabinet meeting 20 April 2017 would consider findings. Draft recommendations to Council 3 May 2017 Consult on draft proposals 8 May 2017 to 31 May 2017 Final recommendation to Cabinet 15 June 2017 Final recommendation to 21 Council June 2017 Final Recommendations and reasons for the decision published and stakeholders informed on 22 June 2017 Recommendations implemented from 1 December 2017 (if changes were required to Parish Boundaries) Implementation will be dependent upon publication of a re-organisation order

An integral part of the review was to consult with the local government electors for the area under review and any other person or body, including a local authority (i.e. the Parish Council) who appeared to have an interest in it.

A range of consultation mechanisms were proposed including:-

• A letter to every local government elector explaining the issue with a consultation reply slip attached that asked for views. A business reply envelope would be provided

• Review Notices would be placed on the web, in Municipal Buildings, Billingham Customer Services, and displayed within the Parish

• An item would be placed on the Parish Council agenda meeting to raise awareness

• Awareness raising with Ward Members via letters and a Member drop in session.

• A letter to the Locality Forum advising the review was ongoing

- Press releases at each key stage
- Stockton News Article

Key Stakeholders would include:-

- Lead Petitioner
- Residents' Groups
- Ward Councillors
- Grindon Parish Council
- MP

Cabinet had considered the matter at their meeting held on 1st December 2016 and a copy of the relevant minute extract was attached to the report.

## C Motion

The following motion had been submitted in accordance with Council Procedure Rule 12.1. The motion was moved by Councillor Paul Rowling, seconded by Councillor Carol Clark:-

"This Council recognises that all Councillors are Corporate Parents to all children and young people in the care of Stockton-on-Tees Borough Council. We note our special responsibility for those in our care and take seriously our role in championing their needs and protecting them from harm.

### C Members' Question Time

## 87/16

The following question had been submitted by Councillor Chris Clough for response by the Leader of the Council:-

"In recent years the fraudulent use of the Blue Badge Scheme seems to have become endemic. The thoughtless use of disabled bays, by those not entitled to do so make the lives of disabled people even more difficult.

Will the Leader condemn the use of Disabled Bays by those using a Blue Badge fraudulently?

The Leader of the Council responded with:-

"I would like to confirm that the Council takes Blue Badge fraud very seriously and is proactive in dealing with this matter. In fact, last financial year, 44 badges were seized by the Council's Enforcement Service for misuse under the Disabled Persons Act 2013.

If our Enforcement Officers suspect that a badge is being used fraudulently then they have to wait and observe the driver returning to their vehicle whereupon they will inspect the badge and seize it if appropriate. Any persons parking in a disabled bay without displaying a badge would be issued with a Penalty Charge Notice."

The following question had been submitted by Councillor Chris Clough for

response by the Leader of the Council:-

Will the Leader promote a Stockton wide publicity campaign against the fraudulent use of Blue Badges?

The Leader of the Council responded with:-

"I can reassure Members that the Council is proactively tackling this issue. We have previously used Stockton News and specific press releases tackling this issue. This will of course continue in the future as appropriate. In addition, the Council's website has a page of information and this is to be updated in the near future to highlight the issues of misuse.

Of course, It should be pointed out enforcement can only be carried out within the Council's car parks and on the public highway. Private car parks including supermarkets and many neighbourhood shopping parades fall outside of this remit where it is the owner's responsibility to carry out enforcement."

The following question had been submitted by Councillor Chris Clough for response by the Leader of the Council:-

"Will the Leader ensure that Parking and Enforcement Officers take a more proactive approach in policing Disabled Bays throughout the Borough?"

The Leader of the Council responded with:-

"I am satisfied that the Council maintains a robust approach to Enforcement in Council operated car parks to help tackle cases of abuse with regard to Blue Badge misuse."

Councillor Chris Clough asked the following supplementary question:-

"Will the Leader of the Council work with and liaise with the private landlords, including supermarkets to make sure they also police the disabled bays as this is where the main problem is?"

The Leader of the Council responded with:-

"I totally agree with you Councillor Clough, our car parks are enforced and if a car hasn't got a Blue Badge it will get a penalty notice on it. In the past we have written out to supermarkets and it is something we can do again.

I'm hoping for a Select Committee to consider this matter in the next Municipal Year. Representatives from the supermarkets and other private car parks might be invited to attend to give evidence on how they enforce their polices within their own car parks.

I'm all in favour of ensuring that the disabled spaces that we provide for disabled people to park are enforced, which we do in our own car parks, but in private car parks as well."
