13 Appointments to Committees, Panels and Joint Bodies for the 2021 - 2023 Municipal Years

At its Annual Meeting, held on Wednesday 22 May 2019, the Council approved appointments to its committees, panels and joint bodies, for the four year period of 2019 to 2023. Since then, a number of amendments, requested by political groups to change membership within their party/group, had been submitted to Council meetings, for approval. In November 2020, the Council agreed changes to committee memberships, which were necessary because of vacancies that had occurred within the whole Council's membership.

Members were aware of the elections, held on 6 May 2021, to fill five vacant seats on the Council. The results of those elections had prompted a review of political proportionality across all Committees, Panels and Joint Bodies. All political groups had been consulted during the review, to advise them of proportionality and to establish their wishes. Members were presented with a report that dealt with the outcomes of that review and presented Council with the appointments and changes necessary due to the change in political proportionality and the nominations to the affected committees, panels and joint bodies requested by political groups. Some amendments may have been proposed to change one member of a group for another for party reasons where it did not affect the political balance.

Appendix 1 of the report detailed the changes that will assist the Council to achieve, as far as is practicable, political proportionality on its Committees etc.

Appendix 2 of the report presented the membership of the Council's Committees, Panels and Joint Bodies should the changes, detailed in Appendix 1, be approved. Council noted that not all Committees, Panels and Joint Bodies had a change in membership, and they had not been included in the Appendices.

Appendix 3 detailed a vacancy and nominations that had emerged during the review.
