## **C Presentation of MOD Employee Gold Award**

The Borough had a long and proud history of supporting the armed forces. The Council was one of the first to sign the Armed Forces Covenant in February 2012 pledging to deliver the Covenant principles in the area:

- Firstly, by seeking to ensure that the local armed forces community was not disadvantaged as a result of their military service; and
- Secondly, by seeking to ensure they had the same access to goods and services as any other citizen of our country.

Several years ago, the Ministry of Defence introduced its 'Employer Recognition Scheme' with 3 award levels Bronze, Silver and Gold to recognise organisations who had supported the armed forces and encouraged and inspired others to do the same.

Having previously been awarded the MOD's bronze and silver awards in 2016, the Worshipful the Mayor was delighted to say that the MOD had selected the Council as a 'Gold Award winner' in its 2021 Employer Recognition Scheme for being a champion supporter and advocate for the defence community.

At the core of this achievement was the backing of the Council, the Corporate Management Team, and the Armed Forces Champion, to establish a Covenant Steering Group consisting of internal and external 'Covenant Champions' from across the Council's services, and its partners (such as housing, education, social care, customer services, benefits, employment, business development, and the clinical commissioning group).

The Worshipful the Mayor presented the Armed Forces Champion, Councillor Bob Cook with the Gold Award. The Worshipful the Mayor thanked all those involved for their hard work and commitment, which had helped bring this national recognition to the Council; and given a strong platform to continue making progress in helping, supporting and honouring our armed forces community.

**42/21**      **Constitution Update**

Consideration was given to a report on the Constitution Update.

All Local Authorities in England had a statutory duty under the Local Government Act 2000 to maintain an up-to-date Constitution and to make their Constitution publicly available.

In addition, para 1.37 of the Stockton on Tees Borough Council Constitution includes the following provisions:

Para 1.37 "The Monitoring Officer on behalf of and in consultation with the Managing Director, will monitor and review the operation of the Constitution on a regular basis, in order to ensure that it is up to date and may make amendments to ensure that legislative references are updated, it reflects the Councils structures and decision-making requirements and any other required changes are made."

Para. 2.4 "The Council will adopt the Council's Constitution and approve amendments to it (except where specifically delegated to the Monitoring

Officer)”

The report sought Council approval for the changes required to update the version of the Constitution which was considered and approved by Council in November 2020.

RESOLVED that the proposed amendments identified in the report and supporting papers be approved.

## **C 43/21 Council Tax Reduction Scheme (CTR)**

Consideration was given to a report on the Council Tax Reduction Scheme (CTR).

Further to consultation approved by Cabinet in June 2021 in respect of proposed changes to the Council's Council Tax Reduction Scheme (CTR), formal consultation had been completed and responses analysed.

The proposed new scheme approved for consultation in June 2021 included a number of features, examples included:

- More support shall be given to those households on the lowest of incomes than in the current scheme;
- Those on the lowest incomes paying no council tax at all;
- Households with higher levels of income will receive less/no CTR;
- The current means-tested schemes will be replaced by a simple income grid model;
- Protection for low-income families with non-dependants living at home;
- Income such as child benefit, disability benefits and personal independent payments will be disregarded;
- An earnings disregard to encourage work will be retained however this will be standardised at £25 per week;
- The current savings allowance of £6,000 will continue but where savings are held above this threshold there will be no entitlement to CTR; (note proposed further change to capital allowance referred to at paragraph 6 of the report).

The consultation produced responses from organisations, major preceptors and the public; with 133 completed questionnaires, a summary of which was included in Appendix B to the report and revealed that the consultees supported the recommended new CTR scheme with a majority in agreement with all 9 principles. Only two of these principles returned a less than 6% majority, the details of which were summarised.

The number of households claiming CTR increased suddenly as a result of Covid-19 rising from 11,421 working age claimants in March 2020 to 12,597 in July 20. Numbers were now showing a steady decline with the total number reducing to 11,681 at 30 September 2021. Since the full roll out of Universal Credit commenced in Stockton in 2018, the make-up of the claimant base had seen a shift from a majority of claimants receiving housing benefit to a majority receiving universal credit.

One of the features of universal credit was that it was responsive to changes in

household income month by month. This meant that people might find that their universal credit was adjusted on a near monthly basis and each time universal credit is adjusted, there is an impact on CTR, resulting in a new council tax bill being sent. The proposed new income banded CTR scheme addressed this issue with small changes no longer triggering an adjustment. This made it much less volatile to claimants and much easier to understand.

The proposed scheme also provided additional support for the most financially vulnerable residents, providing 100% reduction to the lowest income households. Modelling had continued since the last report to Cabinet in June 2021; the reducing caseload now suggesting that under the proposed scheme 8,707 (72.5%) will receive more support including 7,437 households that will no longer have to pay council tax at all. With the scheme targeting the lowest income households, some households with higher levels of income will be adversely affected; modelling suggests this would be 2,665. Of the 2,665 households that are adversely affected, 2040 (76.5%) will still be eligible for a reduction of either 50% or 25% depending on their household income; 625 (23.5%) will no longer be eligible for CTR these being households with higher income levels.

Under Section 13A (1)(c) of the Local Government Finance Act 1992, the Council's exceptional hardship scheme already exists to support households whose financial circumstances impact their ability to pay council tax. In order to protect households that are adversely affected by the changes and where any applicant is likely to experience exceptional hardship, they will be encouraged to apply for an exceptional hardship payment. The Council will consider all applications for exceptional hardship on an individual basis, taking into account available income and essential outgoings.

Ahead of the proposed scheme coming into force on 1 April 2022, households that are adversely affected will be identified and contacted with details of the changes and offering support as appropriate.

In addition to this support for residents experiencing exceptional hardship, residents will be supported through the Council's welfare support team to maximise their income and through the Employment and Training Hub to help support people into employment.

RESOLVED that:-

1. The Council Tax Reduction scheme, included at Appendix A to the report, be adopted for working age customers with effect from 1 April 2022.
2. The Director of Finance, Development and Business Services be authorised to amend the Council's Council Tax Reduction scheme for working age customers to adjust the appropriate calculative elements of the scheme to give effect to national changes.
3. The impact of the changes be monitored and where necessary the scheme will be adapted in future years.

45/21**      **Motion**

The following motion had been submitted in accordance with Council Procedure Rule 3.40 moved by Cllr Tony Riordan, seconded by Cllr Lynn Hall:-

“In early October, Transport Secretary, Grant Shapps, announced that a competition will be run to identify the new headquarters for GBR, the single, accountable public body that will be responsible for running Britain’s railways from 2023.

The Transport Secretary has committed that the national headquarters will be based outside of London and the competition is set to recognise towns and cities with a rich railway history.

Stockton’s rich railway history makes it a perfect contender to be the new home of Great British Rail. A dinner held in Stockton Town Hall in 1810 led to the creation of the Stockton & Darlington Railway (S&DR). In 1822, the first rail was laid for the S&DR at St John’s Well in Stockton. In 1825, the first ever rail passenger was booked at the world’s oldest ticket office in Stockton.

Stockton South MP, Matt Vickers, has recently launched a campaign to bring Great British Railway’s headquarters to Stockton in order to secure new skilled jobs and investment for the area. The bid already has the backing of former Cabinet minister and presenter of ‘Great British Railway Journeys’, Michael Portillo, who has previously called Stockton “the start of the world’s railways”.

This Council:

- 1) Supports the campaign to establish the new headquarters of Great British Railways in Stockton.
  - a. Commits to writing to the Transport Secretary in support of the campaign.
- 2) Regrets that Stockton's rich local railway heritage has been overlooked and neglected.
  - a. Commits to seeking more opportunities to commemorate and celebrate Stockton's link with the world's railways."

Moved by Cllr Jim Beall, seconded by Cllr Bob Cook that the substantive motion be amended as follows:-

"Delete recommendation 2 and 2a.

Replace with:

- 2) Notes Stockton's vital contribution to the birth of passenger railways.
  - a. Commits to seeking more opportunities to commemorate and celebrate Stockton's railway heritage, in particular through the celebration of the 200th anniversary of the inaugural journey, in 2025."

Following a debate a vote took place and the amendment was carried and therefore the amendment became the substantive motion.

No further amendments were moved so a vote then took place on the substantive motion.

The substantive motion was carried as follows:-

"This Council:

- 1) Supports the campaign to establish the new headquarters of Great British Railways in Stockton.
  - a. Commits to writing to the Transport Secretary in support of the campaign.
- 2) Notes Stockton's vital contribution to the birth of passenger railways.
  - a. Commits to seeking more opportunities to commemorate and celebrate Stockton's railway heritage, in particular through the celebration of the 200th anniversary of the inaugural journey, in 2025."

### **Members' Question Time**

The following question had been submitted by Councillor Ted Strike for response by the Leader of the Council:-

"How can a 21-year-old sports complex get into such a bad state that it needs demolishing and replacing? Where would the money have come from if we had not bought Dunedin House and "saved" £24m?"

The Leader of the Council responded with:-

“The report to Cabinet in July 2021 outlined the reasons for the development of a new facility as part of the waterfront development. The building needs investment of over £5m with the changing areas and flumes needing over £1m on their own. If we had not taken the opportunity to develop a new exciting facility then would have been a pressure on the MTFP and considered as part of a future budget process.”

Councillor Ted Strike asked the following supplementary question:-

“Why has this serious issue not been brought before Members attention previously? Can the Leader of the Council advise who is to blame for this major failing? Would it be the builders or maintenance issues by Stockton-on-Tees Borough Council?”

The Leader of the Council responded with:-

“We inspect our buildings on regular basis and these are the issues that can arise on these type of buildings. The flumes themselves will need replacing as they have a limited lifespan. There is nobody to blame for the situation and this is an opportunity for a new building because of the new waterfront development.”

The following question had been submitted by Councillor Ted Strike for response by the Leader of the Council:-

“Following the Government’s disgraceful refusal to grant Billingham a Levelling up grant, will the council be reapplying? What are the Councils plans going forward if it is refused a second time and what are the time scales of the proposed actions?”

The Leader of the Council responded with;-

“I must on this occasion agree that the Government’s decision to refuse to award levelling up funding to Billingham was disgraceful. Of course we welcome the success of the levelling up bid for Stockton South but we must continue to hold the Government to account for the true meaning of levelling up.

I have written to the Secretary of State to express my absolute disappointment in the Stockton North decision and have requested detailed feedback as to why our very strong case for Billingham was ignored. Officers are awaiting when this feedback will take place.

I can confirm that the Council will be applying for the next round of levelling up and work is already underway to ensure we are ready to meet the Government’s timescales which we expect to be around the Spring of next year.

We will ensure that we use all the tools and knowledge we have to ensure that Billingham has a rock solid case for investment that the Government can simply not ignore and we will not give up trying until the people of Stockton North are

heard.”

Councillor Ted Strike asked the following supplementary question:-

“Will Cabinet bring forward a fully costed plan for the purchase and demolition and reconstruction of the town centre? And will this Council learn from previous mistakes around costings for the Globe?”

The Leader of the Council responded with:-

“A detailed plan will be brought before Cabinet and this will be shared with Billingham Councillors. Officers are working on a new bid to the Levelling Up Fund but at the moment we still don’t know how much money we will have for the town centre.”
