# C Electoral Review 2020 – Ward Boundary Review – Further Consultation on 50/21 Warding Patterns

Consideration was given to a report on Electoral Review 2020 – Ward Boundary Review – Further Consultation on Warding Patterns.

The Commission had responded to all comments received during their initial consultation on warding patterns and were undertaking further limited consultation on proposal in central and southern Stockton. This included the wards of Bishopsgarth and Elmtree, Fairfield, Grangefield, Newtown, Ingleby, Southern Parishes and Yarm.

Should these revised proposals be adopted it would result in a council size of 57.

The Commission had confirmed that they were satisfied with the evidence received for the rest of the Borough and did not require any further evidence or comments.

The results from this consultation were summarised in an appendix to the report.

The deadline for submission of comments as part of this consultation ended on 10 January 2022 and comments could be submitted direct to LGBC via their

website. Local Government Boundary Commission for England Consultation Portal.

The Commission's Final Recommendations would be agreed and published on the 29th March 2022.

The Final Recommendations would describe the complete set of electoral arrangements, including ward names and locations as well as the number of elected members, alongside parish warding arrangements. These recommendations would be implemented at the next election by means of an Order laid before Parliament.

It was noted that Thornaby Independent Association (TIA) strongly objected to the views of the Electoral Commission. TIA felt that the Boundary Commission had not taken their comments into account. All their original comments and proposals still stood, not only in respect of the annexation of part of the Town of Thornaby-on-Tees into the proposed Ingleby Barwick South ward, but also in connection with the proposals in Mandale and Victoria, Stainsby Hill and Village wards.

RESOLVED that the comments received as part of the consultation on the Local Government Boundary Commission further draft recommendations be noted and they be submitted to the LGBC by the 10 January 2022.
