## **C**      **Minute's Silence** **44/22**

This was the first full Council meeting following the passing of the late Sovereign, Queen Elizabeth II. On hearing of her passing the Worshipful the Mayor wrote to Her Majesty's Private Secretary to send deepest condolences on behalf of members and residents of the Borough.

**C Show Racism the Red Card**

**46/22**

Show Racism the Red Card was a charity that delivered training, workshops, and other resources to tackle racism across the UK. The Council would be supporting their “Wear Red Day” on Friday 21 October by holding an all-day fundraising event for staff including wellbeing sessions, rounders, and 5-a-side football.

The Worshipful the Mayor thanked everyone for showing their support by participating in the photograph before the meeting and encouraged Members to wear red on 21st October and donate to the charity.

The Cabinet Member for Access, Communities and Community Safety reported that Show Racism the Red Card was the UK's leading anti-racism educational charity. Established in England in January 1996, the charity harnesses the high-profile nature of footballers as anti-racist role models to educate against racism throughout the Country. Through their educational workshops, training sessions, multimedia packages, and a whole host of other resources, “Show Racism the Red Card” delivered training to more than 50,000 individuals a year.

At Stockton the Council was proud, once again, to support the Show Racism the Red Card campaign.

**Motion**

The following motion had been submitted in accordance with Council Procedure Rule 3.40 by Cllr Niall Innes, seconded by Cllr Tony Riordan:-

"As a Borough we have many green and open spaces that we all enjoy. Some of these areas have received their names not through any formal process, but through generations of local residents referring to them based on their locality.

With the tragic passing of Her Majesty the Queen, there could be no greater tribute for local areas to make than to be able to name our parks and open spaces after our longest serving and greatest monarch should we wish. Currently no such option is available to us.

I therefore ask that this council produce and implement a procedure that allows applications for the naming of areas of public greenspace and parks as a means of providing a lasting memorial."

Moved by Councillor Bob Cook, seconded by Councillor Lisa Evans that the substantive motion be amended as follows:-

"Replace the last paragraph of the motion with one that reads:-

"Council expands the remit of the Commemoration Working Group to consider applications for the naming of areas of public greenspace and parks."

Following a debate a vote took place and it was agreed that the amendment be carried and therefore the amendment became the substantive motion.

No further amendments were moved so a vote then took place on the substantive motion.

**51/22**      **Members Question Time**

The following question had been submitted by Councillor Tony Riordan:-

“Due the inflammatory/libellous newsletter sent to residents of the Bishopsgarth and Elm Tree Ward in August of this year, is it your intention to take the matter further and seek legal advice?”

The Leader of the Council responded with:-

“I am not aware of the specific leaflet to which you are referring. However I can confirm that if you have any concerns about any publication then I would encourage you to submit a complaint through the appropriate channels.”

Councillor Tony Riordan asked the following supplementary question:-

“If I could bring this to your attention Councillor Cook, this newsletter that was circulated by Councillor Minchella in August this year, it contains defamatory statements saying that a leading member of the Conservative Party is complicit in lawbreaking, it goes on that the Conservative Party from top to bottom stood in a public place and lied to their faces, so this question is exactly the same wording as you were asked last year about a libellous defamatory newsletter on that occasion you said you would be taking legal advice, are you going to take legal advice or are you not because I’m a Conservative member raising an issue?”

The Leader of the Council responded with:-

“No, I won’t be taking legal advice, the leaflet that you are taking about had your name on it and was circulated in the Fairfield Ward and referred to Labour Members and Councillor Perry, I didn’t seek legal advice from the Council I sought legal advice from the Labour Party. If you think that that is a libellous newsletter you should seek legal advice from the Conservative Party. The Council isn’t there to give legal advice on political newsletters. I would suggest that it’s my view that all newsletters and communications should abide by the Nolan Principles and the guidance in our code of conduct.”

As a point of order Councillor Tony Riordan asked for the clarification as to whether last year had Councillor Bob Cook responded as the Leader of the Council or as the Leader of the Labour Party. Councillor Bob Cook responded that he had responded as the Leader of the Council and the Leader of the Labour Party.

The following question had been submitted by Councillor Tony Riordan:-

“It had recently been reported that the Globe Theatre, in the last quarter, saw over £1 million in ticket sales. How much of this money will come back to the council coffers?”

The Leader of the Council responded with:-

“The financial arrangements for the operation of the Globe, by the Ambassador Theatre Group, were set out in Cabinet and scrutinized further through Executive Scrutiny.”

Councillor Tony Riordan asked the following supplementary question:-

“You published a newsletter recently and you quoted a million-pound figure, where did you get that million-pound figure from?”

The Leader of the Council responded with:-

“The Globe has sold over a million pounds worth of tickets sales so that is where that figure has come from.”

The following question had been submitted by Councillor Tony Riordan:-

“In August, the Globe Theatre put on only two shows. Do you think this a good return for the vast amount of money that is gifted to the company, by this council, each year, for promoting and attracting acts to the venue?”

The Leader of the Council responded with:-

“The plan for the Globe is based on an annual schedule of events. August is a quiet month not just at the Globe but most theatres and venues, but I can assure Councillor Riordan that there are well over 100 events planned throughout the year, each bringing significant footfall and spend to the Town.”

Councillor Tony Riordan asked the following supplementary question:-

“The taxpayers of this Borough have been burdened with a hefty £1.65 million to support the Ambassador Theatre Group and audience development and the attraction of artists in years one to five. The bill for last year was £400k which in monthly figures is nearly £33,333. Each show costs the taxpayer of this Borough £16,666, do you think this represents good value?”

The Leader of the Council responded with:-

“When we made the decision about The Globe it was about regeneration and encouraging the night-time economy of the town centre and obviously it is doing that job of bringing footfall into the town centre. Over the last year people from within the Borough and from outside the Borough have come into the town centre.”
